#### **AMENDMENT 001**

This amendment is raised to answer questions submitted by bidders.

#### **QUESTIONS**

1) Must there be someone on site seven days a week, or can the pruning of trees and maintenance of trails and paved areas be done at the same time as the lawn mowing?

Answer: The work schedule for these services is from Monday to Friday. Pruning of trees and maintenance of trails and paved areas may be done at the same time as the lawn mowing.

2) Are trucks and trailers to be driven onto the barge, and how often does it cross to the island?

Answer: Yes, the truck and trailers are to be driven onto the barge. Usually, departure from the mainland occurs between 7:00 and 7:30 a.m. Once the work is completed, the barge captain can bring you back to the mainland.

3) After day 1 of cutting, may we leave the tractors on the island until the next day?

Answer: No. The grass cutting work must begin and end the same day. The work must be completed by 3:00 p.m.

4) Is there a location on the island where we can store some equipment such as: hedge trimmer, edger, blower, manual lawnmower, etc.

Answer: No. The contractor must not leave any equipment on the island or the mainland site.

5) Are the times of 7:30 and 15:30 indicated the statement of work the first and last trips made by the barge?

Answer: No, these are the workday start and end times of a Parks Canada employee at Fort Lennox. By the same token, these indicate the maximum time allotted to complete the work.

6) We would also like to know the value of the contracts from 2015 to 2020 for analysis purposes.

Answer: The last contract covered the 2019 and 2020 seasons. The overall value of the awarded contract was \$115,200.00 (taxes extra). For further information on past contracts, please refer to the Access to Information services.
