**2. Questions and Answers**

**Question 3**

Category 6A - Items #1, 2, 3, 6, 11, 13, 15 - *"Back fabric must be different from the seat fabric."*

Would you accept a chair that is upholstered in a single fabric which is compliant with this GoCUID?

**Answer 3**

No this will not be accepted as an option.

**Question 4**

Category 6A - Items #1, 6 - *"Must have a pedestal swivel base with an auto-return mechanism that pivots on the pedestal's axis."*

Would you accept a chair that has a 4-prong spider base which is compliant with this GoCUID?

**Answer 4**

If the 4-prong spider base still allows the seat to swivel, we will accept it as a pedestal style base.

**Question 5**

Category 6A - Item #3 - *"Fixed Pedestal base"*

Would you accept a chair that has a 4-Leg post-leg base which is compliant with this GoCUID?

**Answer 5**

No, this will not be accepted as an option.

**Question 6**

Category 6A - Items #4, 5 - *"Tablet arm chair must come with shelf below and cup holder."*

Would you accept an alternative without the Cupholder and Shelf underneath and on fixed legs which is also a compliant GoCUID?

**Answer 6**

No, chair must have four casters and two must be lockable. Tablet arm chair must come with shelf below. Providing a cup holder is optional.

**Question 7**

Category 6A - Item #7 - *"Bar height shelf attached to the back of modular bench back running parallel to all sides of the bench."*

Can you move this into a Non-SA category, the compliant GoCUID is not what the description explains.

**Answer 7**

No, the requirement will remain as is. Please refer to Change Notification - CN002, Annex A, section 3.8 Category 6: Seating, .8 – Modular Benching and Side Table Unit – Curvilinear, subsections .1.5, .2.5

**Question 8**

Category 6A - Item #8 - GoCUID 6CCTVAROLL30XXXJNXX

Would you accept a wood veneer alternative? (6CCTVAROLW30XXXJNXX)

**Answer 8**

No, this will not be accepted as an option.

**Question 9**

Category 6A - Item #10 - GoCUID 6CKIVAREWL48L96TYXX

Would you accept an alternative that offers an End Gable support? (6CKIVAREGL48L96TYXX)

**Answer 9**

Yes, this End Gable Support will be accepted as an option.

GoCUID: 6CKIVAREGL48L96TYXX will also be acceptable.

Would you accept an alternative which material is a Bent Plywood? (6KKCSAxxSP16XXXMONX)

Yes, Bent Plywood will also be accepted as an option. Bent Plywood will also be accepted for Item #2, Tag B2.

Category 6D - Item #1, 2

Would you accept a GoCUID compliant product with the following specifications?

Worksurface Height: 24"H-30"H

Worksurface Depth: 29"D - 31"D

Worksurface Length: 19"W x 22"W

Worksurface Material: Painted MDF

Privacy Screen Material: Fabric (Single Upholstery)

**Answer 13**

Response to category 6D, Item 1

Surface height: will not be accepted as an option. Height must be 30" from the floor to the top of the surface with - 1" tolerance (-25mm)

Surface depth: Will not be accepted as an option Depth to be 24" with a 1"+/- tolerance. (+/- 25mm)

Surface length: Will not be accepted as an option. Length must be a minimum of 48" wide (1219mm).

Surface material: No, MDF will not be accepted.

Privacy Screen: Yes, privacy screen must be available in fabric and/or high pressure laminate.

Response to Category 6D, Item 2

Surface height: Yes, that will be acceptable.

Surface depth: Must allow for the following:

-Work surface or tablet must be orientated in front of the user for use of a laptop or tablet.

-Work surface or tablet must be able to provide for laptop display viewing distance from 15.7" (400mm) to ≤ 29.5" (750mm), the front edge of the surface must be able to be comfortably reached and support the user's wrist under sitting position without stretching forward.

Surface length: Must be no less than 14" (356mm)

Surface material: No, MDF will not be accepted.

Privacy Screen: Yes, privacy screen to be available in fabric and/or high pressure laminate.

**Question 14**

Category 6E - Item #8 - *"Back fabric must be different from the seat fabric."* *"Fixed Pedestal Base*

Would you accept a chair that is upholstered in a single fabric which is compliant with this GoCUID?

Also with a four post base?

**Answer 14**

No, this will not be accepted as an option.

**Question 15**

Category 6E - Item #1 - GoCUID 6SBBTWXXLUW3G19LMYN

Would you accept an alternative that includes arms? (6SBATWXXLUW3G19LMYY)

**Answer 15**

No, this will not be accepted as an option.

(6SBATWXXLUW3G19LMYY)

No, this will not be accepted as an option.

**Question 18**

Category 6E - Item #5 - GoCUID 6MMTSMREPL30L60WNNX

Would you accept an alternative with post legs? (6MMTSMRELL30L60WNNX)

**Answer 18**

No, this will not be accepted as an option

**Question 19**

Category 6E - Item #9 - Non-SA

Would you accept a bench at 52"W?

**Answer 19**

No, this will not be accepted as an option.

**Question 20**

Category 6A - item #7, Tag A7, would a tablet height of 36"h be acceptable and a tablet depth of 12" deep? The tablets are not on the SA and not included with the GoCUID code that was used so I assume there is some latitude in the specifications.

**Answer 20**

No, this will not be accepted as an option.

Please refer to Change Notification - CN002, Annex A, section 3.8 Category 6: Seating, .8 – Modular Benching and Side Table Unit – Curvilinear, subsections .1.5, .2.5

**Question 21**

Category 6A - Item #3

Will the client accept 4 legs as an option to align compatibility with item 2?

**Answer 21**

No, this will not be accepted as an option.

**Question 22**

Category 6A - item #7

The SA does not call for a bar shelf to be attached to the modular bench. Adding this fundamentally changes the function of the unit. Please either remove the shelf requirement or move the unit to Non-SA.

**Answer 22**

No, the requirement will remain as is. Please refer to Change Notification - CN002, Annex A, section 3.8 Category 6: Seating, .8 – Modular Benching and Side Table Unit – Curvilinear, subsections .1.5, .2.5

**Question 23**

Category 6E - Item #8

Will the client also accept a swivel base or fixed wire base?

**Answer 23**

Yes, swivel and fixed wire base will also be accepted as an option.

GoCuid: 6SLCOAXXWUXXXXXMXXX will also be acceptable.

**Question 24**

Category 6C - Item #12

Will the client also respectively accept a double writable surface or whiteboard on one side and laminate on the other?

**Answer 24**

Yes, a double writable surface will be accepted. White board on one side and laminate on the other will not be accepted.

GoCuid: 6LWBFWWSXXXXXXXXNNN will also be acceptable.

**Question 25**

Category 6A – Item #9, Tag A9

Would a bar height stool on 4 legs be acceptable?

**Answer 25**

No, this will not be accepted as an option.

**Question 26**

Category 6A - item #12, Tag A12

Is this a round or square ottoman? The GoCUID code says square but the descriptions says diameter.

**Answer 26**

This is a square upholstered stool with casters, range to be 18" – 20".

**Question 27**

Category 6C - item #8, Tag C7

Would dimensions 13Wx16Lx26H be acceptable?

**Answer 27**

No, this will not be accepted as an option.

We will accept a range from:

Depth: 15" (381mm) – 18" (457mm)

Width: 19" (483mm) – 24" (610mm)

**Question 28**

Category 6A - Item #1, Tag A1

Would the client accept a chair with 360 degree swivel capabilities but no auto-return mechanism? Please advise if either one of the bases shown below be acceptable.



**Answer 28**

No, we will not accept a chair with 360 degree swivel capabilities, but not auto-return mechanism.

Yes, we accept the bases shown as pedestal style bases.

**Question 29**

Category 6A - Items #2, 3, Tag A2 & A3

Client requests that both the sofa & lounge chair be from the same series. In order to keep the look consistent within the two, would the customer allow for the base on the lounge chair to be the same as on the sofa i.e. on legs vs. the requested pedestal base? If not, would the client accept that the lounge chair be from the same manufacturer with the same finishes available but not be from the same series?

**Answer 29**

Yes we will accept the lounge chair to be from the same manufacturer with the same finishes available, but not necessarily from the same series.

**Question 30**

Category 6A - Items #4, 5, Tag A4 and A5

Would the customer allow for tablet arm chairs without a shelf below?

**Answer 30**

No this will not be accepted as an option.

**Question 31**

Category 6A - Item #6, Tag A6

The GOCUID states that the base be fixed, however the description states an auto-return mechanism is required, can you please clarify which is desired?

**Answer 31**

The GoCUID provided is for a swivel base and an auto return mechanism is required.

**Question 32**

Category 6A - Item #6, Tag A6

If a swivel base is required, would the client accept a base with 360 degree capabilities but without an auto-return mechanism?

**Answer 32**

No, we will not accept a chair with 360 degree swivel capabilities, but not auto-return mechanism."

**Question 33**

Category 6A - Item #14, Tag A14

Would the client accept felt or acoustical freestanding panels as well?

**Answer 33**

No this will not be accepted as an option.

**Question 34**

Category 6D - Item #1, Tag D1

As per the supply arrangement standard, "*Privacy screens must be fabric covered, high-pressure laminate, or low-pressure laminate.*" Can the client confirm that one of three is acceptable and that they do not need to be offered in both?

**Answer 34**

Yes, privacy screen must be available in fabric and/or high pressure laminate. Low pressure laminate will not be accepted.

Please see revised Category 6D - Table 1 – Product Table included in this amendment (003)

**Question 35**

Category 6D - Item #2, Tag D2

Specifications seems to favor a specific manufacturer and eliminates our supply arrangement standard. Can the client confirm that either a pedestal base would be acceptable and or a 20" length tablet arm? If not, would the client allow for a work surface that is not an integrated tablet arm?

**Answer 35**

No we will not accept a pedestal base. We will now accept an integrated or attached worksurface or tablet support arm.

GoCUID: 6OPLWLFLSLXC3H46XYTA and 6OPLWLFLSLXC3H46XYWS will be accepted.  
Worksurface/Tablet length must be no less than 14" (356mm).

**Question 36**

Category 6E - Item #1, Tag E1

Can the client confirm that a breathable upholstery be acceptable as well?

**Answer 36**

No, breathable upholstery will not be accepted.

**Question 37**

Category 6E – Item#2, Tag E2

Description states that Tag “A4” to be ganged on each side to create an L-shape, however A4 is a tablet arm chair. Could you please provide clarification?

**Answer 37**

That was an error. “Tag: A4” should say “Tag: E1”.

**Question 38**

Category 6E – Items #6, 7, Tag E6 & E7

Would the client also accept a fully upholstered base instead of having the ottoman on legs, such as the visual below?



**Answer 38**

Yes, this will also be accepted as an option. Please refer to Change Notification – CN002, Annex A, Section 3.8 Category 6: Seating, .5 Upholstered Ottoman, .5.1, “As per manufacturer’s standard product offering: If legs are not manufacturer’s standard product line, glides to be provided.

**Question 39**

Category 6A - item #1, Tag A1

Would you accept 2 different fabrics being used but one on the inside and one on the outside of the seat and back?

**Answer 39**

No. this will not be accepted as an option.

**Question 40**

Could you please confirm the ceiling height on the floor?

**Answer 40**

Ceiling height is 9'-0" A.F.F. (743mm A.F.F.)

**Question 41**

Category 6A - item #1

Given that they have the same function, would you accept GoCUID# 6KBSBHxxLY15XXXROYX (with 4 legs) instead of a sled base?

**Answer 41**

No, this will not be accepted as an option.

Please note: the reference item is for a lounge chair. The GoCUID provided is referencing a kitchenette chair. All kitchenette chairs/ and stool to be sled base.

**Question 42**

Category 6A - item #15

Given that they have the same function, would you accept GoCUID# 6KBSCHxxLY15XXXPOYX (with 4 legs) instead of a sled base?

**Answer 42**

No, this will not be accepted as an option.

**Question 43**

Category 6D - item #1, 2

The SA specifications for open area collaborative furniture does not have a requirement for data; only for power and USB. Could you please remove the requirement for data for these items?

**Answer 43**

Data requirement has been removed.

**Question 44**

Category 6A - item #3

Typically pedestal base chairs have swivel bases. Would you accept GoCUID# 6SLCWAXXWUXXXXXMXXX (with swivel/return base) instead of a fixed pedestal base?

**Design Upgrade Rule:**

The IU may exercise an option to upgrade products up to 20% of each Category product total before Applicable Taxes after contract award.

The Design Upgrade amount is used at the discretion of the Project Authority (PA) **prior to the manufacturing/ordering of the products**, the PA will provide the Contractor with a written notice of Canada's Design Upgrade choices for each of the product(s) to be upgraded. The Contractor will provide the pricing of the upgraded product(s) to a maximum of 20% of each Category Contract Price of Table 8. The Contracting Authority will issue an amendment to the contract with the Design Upgrades and pricing.

The Supplier certifies that all the Design Upgraded products offered will conform to all specifications and meet the testing requirements detailed in the Specifications of the Supply Arrangement.

Design Upgrade: is the process of replacing a product with a more innovative or enhanced version of the same product.

**NSA:**




