Question 43:

Please confirm references needed for M2 must be greater than \$5 million dollars.

Answer 43:

Appendix A to Attachment 4.1 is the table to be used to respond to M2. There is no mention in mandatory Criteria M2 that references have to be greater than \$5M.

M2 is amended below to remove the reference to Appendix B. See amendment below.

Question 44:

Regarding appendix B to attachment 4.1, former versions required task substantiation only for **“Non-M2-Matching Categories ONLY”**. The current version excludes the statement. Are we now required to list tasks (at least 50%) where referenced contracts include the same or higher level categories?

Answer 44:

The requirement to list at least 50 % of the Statement of Work tasks does not apply to referenced contracts that include the same or higher level categories. However a summary of the scope, resource categories provided and key responsibilities specific to the development and operational support of the Informatics professional services must be provided.

Question 45:

Would the Crown accept a reference for the Phoenix Pay System as being compliant with the definition of a Financial Management System as stated in R4?

Answer 45:

No, Canada will not accept a reference for the Phoenix Pay System as being compliant with the definition of a Financial Management System as stated in R4?
