AMENDMENT 001

The purpose of Amendment 001 is to respond to Bidders questions.

Question 1:

Has there been an incumbent within twelve months (or greater) either as a Term, Casual, or Agency Contract (THS, TSPS, TBIPS) performing these duties?

- a. If so, what is the name of the incumbent Vendor, and have they been invited?
- b. If so, can you provide the number of days worked on said contract along with the dollar value?

Response 1:

Yes, there have been similar services provided in the past and there is an incumbent.

- a. A contract was awarded to Valcom Consulting GroupInc. (SC2015-01).
- b. The contract is valued (taxes incl.) at \$680,350.00. The total contract period is from 27 January 2016 to 16 April 2021.

Question 2,3,4:

- a) M3 requests experience in 7 out of 9 airworthiness activities. Yet there are only 8 activities listed: A-G followed by I, while H is missing. Please clarify this.
- b) M8 lists six different responsibilities (a-f), but it is not clear how many items from the list a proposed resource is required to have in order to be compliant. Are resources required to have experience in all 6 areas, 'a' through 'f'?
- c) In response to solicitation W8485-21-SC08, would the client consider amending M3 on page 15 to "the Bidder's proposed resource must have a demonstrated 2 years combined experience in the previous ten years in aircraft engineering and technical support for **three (3)** out of the nine (9) airworthiness activities listed below"? This will open up the candidate pool significantly to include more qualified consultants."

Responses:

- a) There are 8 airworthiness activities. We will update M3 accordingly. Resource must have experience in 7 out of 8 airworthiness activities. A to H (I will be considered H)
- b) A to F are the only activities that can count to demonstrate 5 years of experience. The contractor does not need to have done all 6 activities but has done them for a period of 5 years. So if for Year 1, the Contractor worked on A and on Years 2,3,4,5 he worked on B then it is appropriate as he has accomplished the experience we are looking for, in the length of time we require (5 years total).

The proposed resource must possess a minimum five (5) years demonstrated experience in the last ten (10) years in engineering or technical writing. Only the actual authoring of work related to aircraft technical issues or aerospace organizational issues captured in the following will be considered as demonstrated experience::

- a. Audit observations or reports;
- b. Technical Memorandums;
- c. Technical Notes;
- d. Technical Briefing Notes;
- e. Flight Safety Reports; and
- f. Airworthiness Certification.
- c) The changed proposed below does not satisfy the needs of the position. Seven out of the Eight airworthiness activities in required.
