


GENERAL NOTES

- 1. THE CONTRACTOR SHALL BE SOLELY RESPONSIBLE FOR ISSUES/PROBLEMS WHICH MAY OCCUR AS A RESULT OF A FAILURE TO FOLLOW THESE PLANS, SPECIFICATIONS AND THE DESIGN INTENT THEY CONVEY.
- 2. WHERE THERE ARE ALLEGED ERRORS, OMISSIONS, INCONSISTENCIES OR AMBIGUITIES PRESENT IN THE CONTRACT DOCUMENTS, THE CONTRACTOR MUST SEEK CLARIFICATION FROM DEPARTMENT REPRESENTATIVE. ANY COSTS OR SCHEDULE DELAYS WHICH RESULT AS A FAILURE TO CONTACT DEPARTMENT REPRESENTATIVE FOR DIRECTION SHALL BE SOLELY THE RESPONSIBILITY OF THE CONTRACTOR.

- 4. DO NOT SCALE DRAWINGS. REFER ANY DIMENSIONAL CLARIFICATIONS AND/OR POSSIBLE TRADE INTERFERENCE/CONFLICTS TO DEPARTMENT REPRESENTATIVE FOR CLARIFICATION PRIOR TO COMMENCEMENT OF THE WORK.
- 5. THE CONTRACTOR SHALL BE RESPONSIBLE FOR ALL COORDINATION WITH SUBTRADES AND SHALL ADDRESS CONSTRUCTION TEAM COORDINATION ITEMS PRIOR TO ISSUING REQUESTS FOR INFORMATION FROM DEPARTMENT REPRESENTATIVE.
- 6. THE POSITION OF POLE LINES, CONDUITS, WATERMAINS, SEWERS AND OTHER UNDERGROUND AND OVERGROUND UTILITIES AND STRUCTURES IS NOT NECESSARILY SHOWN ON THE CONTRACT DRAWING, AND, WHERE SHOWN, THE ACCURACY OF THE POSITION OF SUCH UTILITIES AND STRUCTURES IS NOT GUARANTEED. BEFORE STARTING WORK, THE CONTRACTOR SHALL INFORM THEMSELVES OF THE EXACT LOCATION OF ALL SUCH UTILITIES AND STRUCTURES, AND SHALL ASSUME ALL LIABILITY FOR DAMAGE TO THEM.

EROSION, SEDIMENT AND ENVIRONMENTAL

- 1. ALL ACTIVITIES, INCLUDING MAINTENANCE PROCEDURES, SHOULD BE CONTROLLED TO PREVENT THE ENTRY OF PETROLEUM PRODUCTS, DEBRIS, RUBBLE, CONCRETE OR OTHER DELETERIOUS SUBSTANCES FROM ENTERING THE WATER. VEHICULAR REFUELING AND MAINTENANCE SHALL BE CONDUCTED AT LEAST 30M FROM THE WATER.
- 2. ALL EQUIPMENT SHALL BE CLEANED OF EXISTING DEBRIS FROM PREVIOUS LOCATION TO REDUCE THE SPREADING OF INVASIVE SPECIES INTO LAKE ONTARIO.
- 3. INSTALL MUD MATS IN ORDER TO PREVENT SEDIMENT ONTO THE PAVED SURFACES.
- 4. ALL SOIL STOCKPILE LOCATIONS SHALL BE LOCATED A MINIMUM OF 15 METRES FROM THE LAKE AND SURROUNDED BY SEDIMENT CONTROLS. ALL STOCKPILES SHOULD BE STABILIZED AS QUICKLY AS POSSIBLE.

- 01 DISCONNECT EXISTING 50mmØ WATER SERVICE COMPLETE WITH CURB STOP.
- 02 LOCATE EXISTING 150mmØ SANITARY SERVICE AND DISCONNECT FROM EXISTING BUILDING. CAP AND MAINTAIN FOR NEW BUILDING CONNECTION.
- 03 REMOVE AND DISCARD EXISTING BOLLARDS.
- 04 REMOVE AND DISCARD EXISTING WATER SERVICE.
- 05 REFER TO ELECTRICAL SITE PLAN FOR ELECTRICAL SERVICES SCOPE OF WORK.
- 06 EXISTING 50mm WATER SERVICE AND EXISTING 150mm SANITARY SEWER: (REFER TO DRAWING C3) LIMITED AS CONSTRUCTED INFORMATION CAN BE FOUND FROM TOTTEN SIMS HUBICKI ASSOCIATES DRAWING 3, ISSUED DATED 12.99, PROJECT No. 12-10631-02.
- 07 EXISTING BUILDINGS TO BE REMOVED REFER TO ARCHITECTURAL
- 08 REMOVE AND SALVAGE SIGN. REFER TO DRAWING C2 FOR NEW LOCATION.
- 09 REMOVE EXISTING CHAIN LINK FENCE COMPLETE WITH ASSOCIATED POSTS. REFER TO ARCHITECTURAL DRAWINGS.
- 10 REMOVE GATE COMPLETE WITH ASSOCIATED POSTS. REFER TO ARCHITECTURAL DRAWINGS.
- 11 PROPOSED TEMPORARY COAST GUARD OPERATIONS TRAILER
- LOCATION.
- 12 EXISTING IRON FENCE SECTION TO BE REMOVED TO ALLOW NEW UNDERGROUND SERVICES WORK TO BE COMPLETED. REINSTATE EXISTING IRON FENCE UPON COMPLETION.




