1. Questions and answers 2 and 3

Question 2: We note a certain ambiguity between the following terms used in the RFP: "Principal Offeror", "Offeror", "Principal sub-experts / specialists" at various places in the call for tenders document.

Answer 2: The terms "Offeror" and "principal offeror" refer to the principal advising firm in whose name the offer is submitted. With regard to the term "main sub-experts / specialists", it refers rather to any professional that the main offeror deems relevant to integrate into its team in order to meet the requirements of the standing offer.

Question 3: For technical criterion No. 1 - Achievements of the main contractor and / or sub-expert within the framework of projects. We understand that you are looking to assess the experience of the project manager or specialists in carrying out projects related to the specialty areas of Euro-Quebec History and Indigenous Paleo-history. In the context where the majority of Archaeologists specialists in Quebec are autonomous and independent workers, will you consider projects carried out by these specialists if they are engaged exclusively by the offeror for the provision of services under this agreement of offers to orders?

Answer 3: With regard to criterion no. 1, we will consider all combined experiences whether within the firm or not, its sub-experts and its sub-contractors.
