# 4. SCOPE OF REQUIREMENT:

- 4.1 Under the direction of the Project Authority, the Contractor shall provide storage, delivery, pick-up and maintenance of fifty (50) pack-up kits and individual spare items. The number of pack-up kits may vary over time and be higher or lower than fifty. On an "as and when requested" basis, the Contractor shall purchase and assemble additional pack-up kits and/or individual spare items. The storage/warehousing component must be considered as Global Affairs Canada (GAC) dedicated space area.
- 4.2 Each kit is to be stored in container(s) for ease of storage and transport. Containers will be stored on a wood pallet of three (3) feet, x four' (4) feet. There are fifty (50) kits in all:
  - Twenty three (23) large kits consisting of two (2) cartons, the equivalent of thirty two (32) cubic feet, in dimensions and weighing a total of 222 pounds;
  - Seventeen (17) small kits, consisting of two (2) cartons, the equivalent of twenty five (25) cubic feet in dimensions and weighing a total of 165 pounds.
  - Additional ten (10) kits consisting of two (2) bins each.
- 4.3 Pick-up and deliveries will normally be within 100Km of the National Capital Region, environs.
- 4.4 The Project Authority and the Contractor will conduct an annual inventory of the kit contents and spare items, and inspect the storage facilities.
- 4.5 The Contractor will make available the services of one (1) warehouse employee at their expense for the purpose of the annual inventory of the pack-up kits contents, spare items, and inspection of facilities.
- 4.6 The Project Authority will prepare a Work Order for each delivery/pick-up of pack-up kits; a sample Work Order for pack-up kits is attached hereto as Annex E.

#### 5. MANDATORY REQUIREMENT:

- 5.1 The contractor must have access to a commercial warehouse for the PUKs storage;
- 5.2 The warehouse must have an area of min 500 square feet dedicated to GAC's items.
- 5.3 The warehouse must be clean and have air quality and temperature that would not damage the PUKs.
- 5.4 The Contractor must have the ability to deliver and/or pick up the kits to and from the Client's residence and at Client's convenience between the hours of 8:00 am and 6:00 p.m., unless mutually agreed at another time. Any mutually agreed alternate time outside normal working hours must be in writing;
- 5.5 The Contractor must have the ability to dry clean items, as requested;
- 5.6 The Contractor must have the ability to clean and replace missing and broken items, and prepare the kit for next usage.
- 5.7 The Contractor must have the ability to buy and supply additional PUKs as per inventory list in Annex E and when authorized by the Project Authority.
