## Amendment 001

This amendment is raised to answer bidder questions.

### A. Question and Answers

Q1. Is the campground accessible to bidders at this time?

A1. Red Rock Parkway and the campground are typically inaccessible this time of year. The campground is located in a closed area behind two locked gates, one at the entrance to Red Rock Parkway and the other at the km 6.5 on the parkway at the turn off to Crandell Mountain Campground. On **Monday, March 29th, from 9:00 AM to noon**, the gates will be opened and contractors will be permitted access to the campground. All contractors who plan to visit the site on this date must respond in writing to the contract officer no later than end of day on March 28th.

Q2. Please provide clarification on the electrical pull boxes. Furthermore, do these need to be traffic rated to sustain vehicle loads and what type?

A2. The electrical pull box requirements are detailed on Drawing E-101, references in the drawing include the information requested.

Q3. Is the IBP submission a mandatory bid submission requirement?

A3. No. Bid submissions without any IBP will not be considered non-compliant but will receive an IBP score of zero in the evaluation.
