QUESTION AND ANSWER #1

Question 1

We wanted clarification in respect to the funding for the RFP: Guidelines for Front-line Community Workers on Sexual Exploitation. Can you tell us if the Phase 1 has a separate payment and a ceiling of \$135,000 (applicable taxes extra) and Phase 2 has a separate payment and a ceiling of \$200,000 however work will be subject to the issuance of task authorizations for the required work?

If this is the case, can you explain what the notation on Page 4 indicates: (Phase 1 estimated at 67% and Phase 2 at 34%)?

Answer 1

Phase 1 and 2 is estimated at \$135,000. The overall contract ceiling is set at \$200,000 should similar work arise from this contract or in case Phase 2 proposal is more involved then originally envision based on the Contractor approach for Phase 2 at the end of Phase 1.

Phase 1 is estimated at 67% and a Phase 2 at 34% of the \$135,000 estimate.

Question 2

We wanted to request an extension to the bid closing date of March 31, 2021. This will assist in ensuring the details, as required by the RFP, can be met.

Answer 2

Granted, the Bid closing date is hereby amended to April 14th, 2021 at the same time.
