Question 1:

Apples are sold by the 40 lb (18 kg) box not necessarily an exact 100 count (each)

Response 1:

We know apples are sold in 18Kg case but the reason why we enter the 100 count it's because there are many different counts per case and we want to make sure the suppliers provide us with the 100 counts case and not the others.

Question 2:

Cantaloupe is sold by the count (15/18) not an exact weight.

Response 2:

For the cantaloupe it's the same thing, they are normally sold in 18Kg case and less cantaloupe that are in a case bigger they are. The case size vary from 9 to 18 cantaloupe in a case. On the RMSO for the Ontario we have 1 x 12 ea. For the Wainwright RISO we input what they currently have as their case description for that item but it will be change when we are going with the RMSO.
