- Q1.** Question concerning Annex A Statement of Work section 4.0 Duration and hours. Under section 4.0 the duration of work is stated as May 1st – October 31st. Since the closing of the tender is May 3,2021 when is the projected start time of this year?
- A1.** The start date will depend on the award of contract. It will be confirmed with the successful bidder, but as soon as possible after contract award.
- Q2.** Question concerning Annex B – Contract period
I see that estimated days the first year is 184 which I infer is service 7 days per week. Do you have a stipulated amount of coverage in the terms of hour per day? Is there a specific start and end time each day?
- A2.** Yes, the coverage is seven (7) days per week. As per section 5.1 of the Statement of Work, begin no later than 8:00 am and completion no earlier than 6:00 pm.
