**Q1** We would like to propose an alternate product for the Project. We have attached information on the Flexamat Product to replace Cable Concrete and Rip Rap.

**A1** Please note that alternates will only be considered after award for the successful bidder. Bidders should bid as per the drawings and specifications package since there is no guarantee that an alternate will be approved.

**Q2** I would like to know if there are specific vendors in Saskatchewan to contact for the following materials:

1. non-woven/woven geosynthetics

3. supply of 500mm polymer laminated csp

**A3** Approximately **10 KM** from one end to the other.

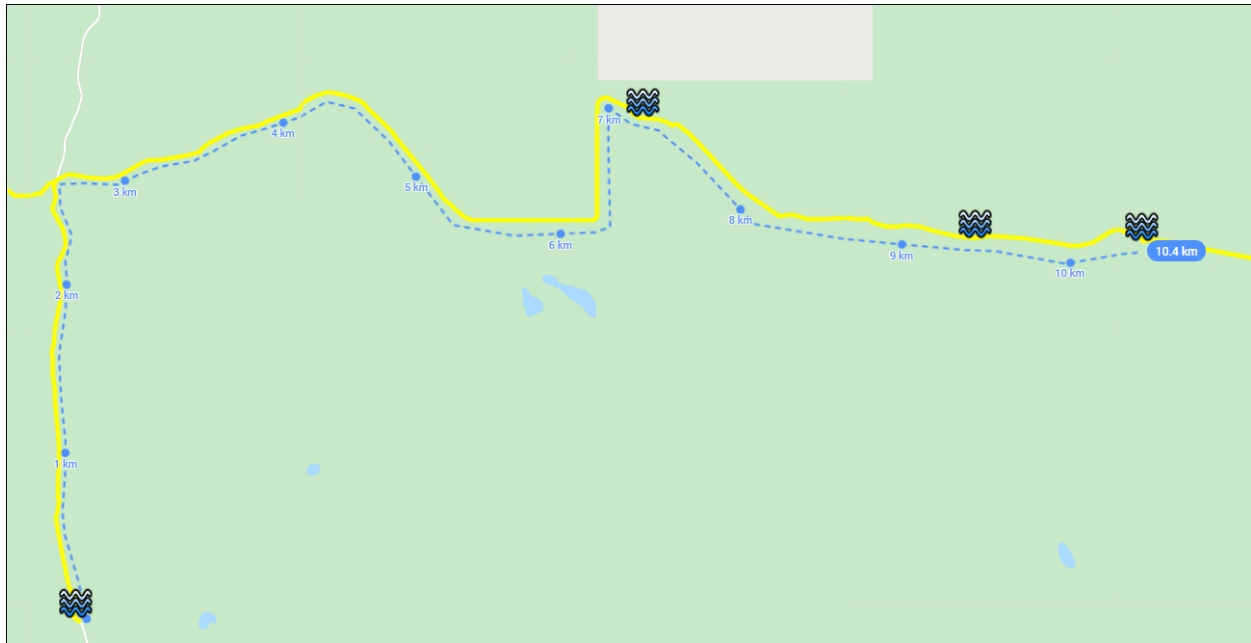

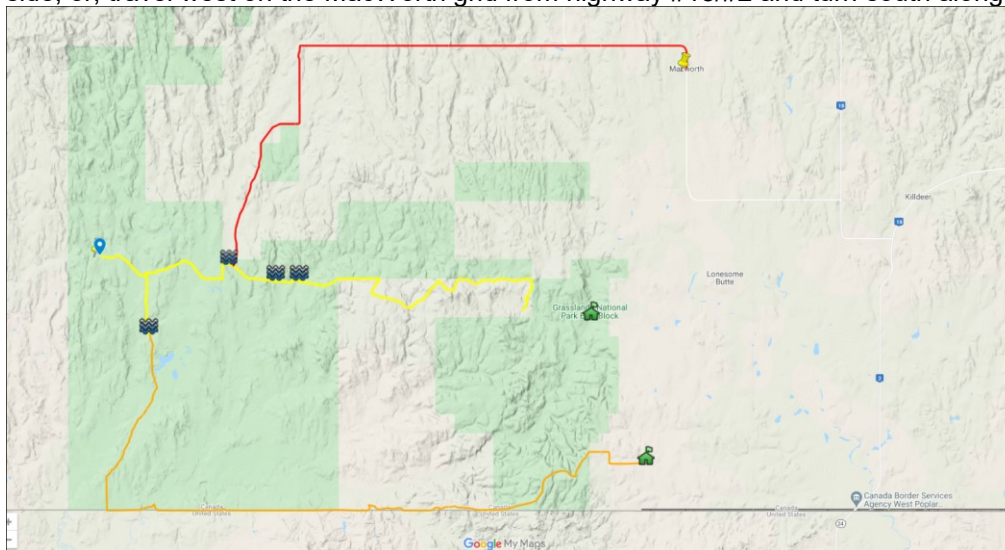

For the closest access via pavement to the area, travel highway #18/#2 to the rural municipality (RM) gravel roads in the region. There are a couple options from this end; travel west on Monea road or West Poplar grid road from highway #18/#2 to Poverty Ridge Operations, entering the park from the far east side; or, travel west on the MacWorth grid from highway #18/#2 and turn south along an RM bladed trail.



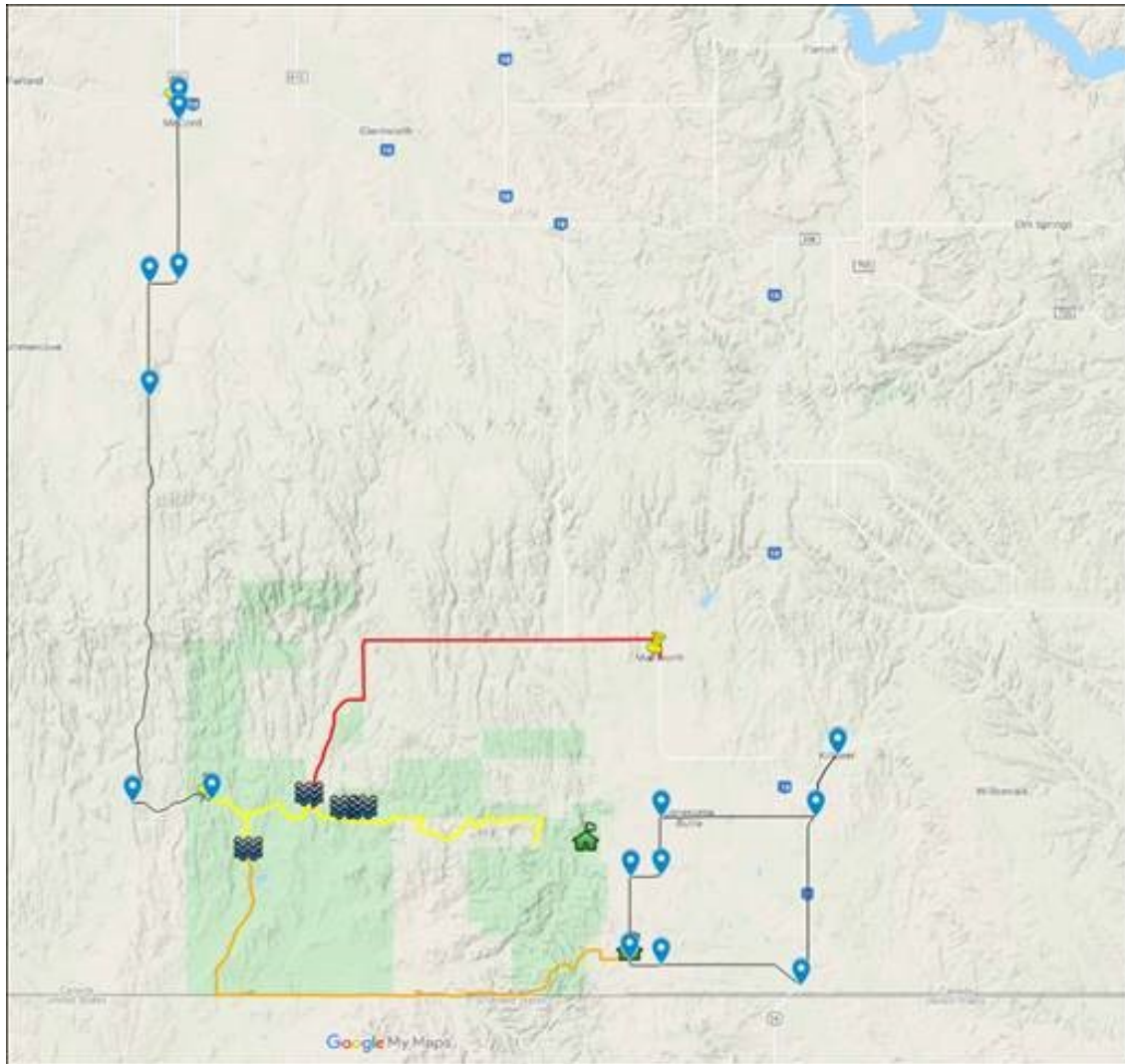

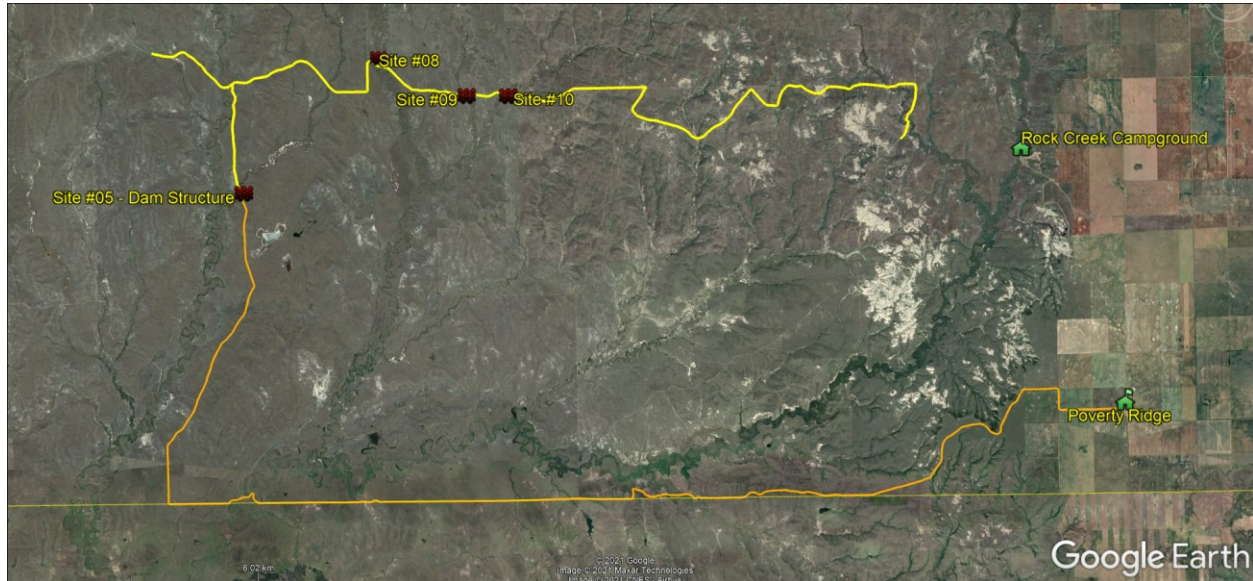

**Q5** How far away is Poverty Ridge from the sites?

**A5** Approximately **33 KM** from **Site #05**



**Q6** About the concrete blocs, you mentioned cable concrete, we have to supplied those?

**A6** On the unit price list all items are separated for the supply of the cable concrete and the install of the cable concrete. Please note that any unforeseen additional work may result in a Change Order.

**Q7** Everything you have in unit price table, those are all the rough number for all project combine of yards of material and cable?

**A7** The unit price table is for all 4 locations combined. Cross reference to the specifications as it provides details for each payment provision and how each item will be paid and if there are anything considered incidental.

**Q8** Are we required to have a bid bond for this project?

**A8** Yes, bid security is required. Please submit via Fax or send to the bid receiving email address as identified on the cover page of the Invitation to Tender prior to the submission deadline. Please note that bids cannot be submitted to the contracting officer's email address.

**Q9** Section 01 35 43 Pg 46 says no grass seed included in this work but that's ok as long as the Park has a representative on hand to seed asap after we place the topsoil otherwise it will erode which brings up another concern that I have and I think Erosion matting should be installed or any topsoil will erode especially with new topsoil. If we could use the existing top that is poor and lumping it may hold in place. Also it is to my understanding that item B1 in the bid sheet is 480 m<sup>2</sup> to be stripped for the new concrete matting and item B13 is 480 m<sup>2</sup> of topsoil to be placed and graded but that can't be correct, please confirm.

**A9** Due to the sensitive nature of the sites, Parks Canada will be performing the seeding after the site is completed and no additional erosion control mats will be required. The contractor is advised to leave the vegetation in clumps in the stripped topsoil and to not fine rake the areas after placement which will assist in Parks Canada's revegetation efforts. For the second part of the question, the quantities are correct as there is no topsoil where the cable concrete mats are being placed, but it is adjacent to the sides of the mats and will need to be moved to facilitate construction, and then replaced.
