The following changes in the tender documents are effective immediately. This addendum will form part of the contract documents.

This Addendum is raised to provide the following answers to questions provided by bidders.

**Q1**

On page 4 of section 00 21 13 under item 1.18 Special instructions it states:

1.18.3            5 CDSB Gagetown is divided into 4 zones for grass cutting. All zones are to be started at the same time so we get uniform cut. Contractors are expected to start concurrently to achieve this uniformity.

Does this contract GRASS CUTTING #1 include only one zone or are there multiple zones within this contract?

**A1**

GRASS CUTTING #1 is one contract/zone which includes different areas outlined in:

**Instructions To Bidders**  
**Section** - 00 21 13  
**Page** – 1  
**Item** – 1.01  
**Paragraph** - .1 & .2

The sentence in 1.18.3

“5 CDSB Gagetown is divided into 4 zones for grass cutting.”

refers to 4 separate Grass Cutting contracts/zones (#1, #2, #3, #4).

See 1.18.4 as well:

.4            If a contractor has more than one Contract/zone, they must identify the equipment, manpower, and on-site supervisor being utilized in each zone to ensure uniformity and work is completed in the time allotted.
