East Gate Landslide Check Dams – Glacier National Park

Amendment 003

This amendment is being raised to distribute questions and answers.

A. Questions and Answers

- **Q27:** Does the access road include the path to the check dams? Can aerial pictures of previous contractors site layout be provided for reference purposes only?
- **A27**: Refer to Section 31 53 13 Log Crib Check Dams, Clause 1.1 for definition of the access road limits. Aerial pictures of the previous site layout are not available.
- Q28: Will imported gravel be required for site access?
- A28: Site access is the responsibility of the Contractor. Historically, imported gravel has not been used.
- **Q29:** There is verbiage of stockpiling catchment cleanout material and placing material. Does this contract include the embankment placement and culvert install? if so, can additional line items be made to include this scope?
- **A29:** No. Catchment cleanout material is to be stockpiled at the East Gate Storage Site as directed by the Departmental Representative.
- Q30: What will be done with the organic matter that is sorted out of the embankment material? Is there a dump area for this material or will it be shipped to a landfill site? Can an additional line item be made for this?
- **A30:** Organic soil (overburden) is not expected. Organic woody debris are to be stockpiled as per Section 31 24 13 Catchment Cleanout.
- **Q31:** Can articulated rock trucks be used to ship the material across the road and along the road shoulder to the allocated dump area?
- A31: Yes, refer to Section 01 14 00 Work Restrictions, Clause 1.11.1.
- **Q32:** What is to be done with the saturated materials or considered unsuitable? If this need to be trucked to a landfill, can additional line items be made for this scope?
- A32: Unsuitable material will be stockpiled at the East Gate Storage Site.
- Q33: Is there a performance bond required for this project? Only requirements we can see is a bid security.
- **A33:** Bid security is required at the time of closing, the awarded bidder will need to provide contract security which can be in the form of performance and labour and material bonds. Refer to R2890D GC9 Contract Security.
- Q34: Can a 1-week extension to the closing date be made?
- **A34:** Parks Canada has considered this request and determined that the closing date will remain unchanged.
