### **Question 1**

**with a score as low as 14%. This seems extraordinarily low for a Tier 2 TBIPS solicitation. Please confirm that a Bidder must achieve a minimum score of 70% (350/500 points) to be considered compliant which is aligned with standard TBIPS Tier 2 solicitations of this nature.**

#### **Question 4**

**M.1.3 – Please confirm that the contracts used to demonstrate compliance against M.1.3 are not required to have been TBIPS contracts?**

**R.1.1 and R.1.2 – These requirements are very similar and appear to be asking for the same information. Can the Crown please clarify the difference between the requirements?**

**R.1.3 – Please confirm that the resources detailed under this requirement are not required to have been provided under TBIPS.**

Answer 4

M.1.3 For any cited non-TBIPS contracts, Bidders must demonstrate that it was awarded contracts to perform the equivalent tasks and delivered the equivalent services associated with the resource categories identified in M.1.3. The definition of those tasks and services are fully described in TBIPS.

R1.1 and R1.2. The former requires citation of two contracts issued by public sector clients, whereas the latter does not restrict the cited contract to public sector clients. Contracts cited in response to R1.1 should not be cited again in response to R1.2.

R1.3 For any cited non-TBIPS contracts, Bidders must demonstrate that it was awarded contracts to perform the equivalent tasks and delivered the equivalent services associated with the resource categories identified. Note: Bidders should cite three (3) Application/Software Architects Level 3 (NOT one Level 2 resource and two Level 3 resources). This aligns to the first three rows in the response table for R1.3.
