**Solicitation amendment 001 is to answer questions from the industry.**

**Enquiries – Bid solicitation – Clause #2.3**

To ensure consistency and quality of information provided to bidders, significant enquiries received and the replies to such enquiries will be provided simultaneously to bidders to which the bid solicitation has been sent, without revealing the sources of enquiries.

**Here is the question that we have received:**

**Question 1 :** We have a question for you regarding the ABS certification of these doors. It is our understanding that under the terms of IACS, (International Association of Classification Societies) that under the terms of IACS, each of the Class Societies can accept each others Class Approvals. Therefore it is our understanding that if our door manufacturer provided you with the same doors with the same approval, except it would be ( CIE «X» ) approval, a member of IACS, the doors would be acceptable to you. We would use the same drawing of the doors , have them approved by ( CIE «X» ), then inspected and certified the same as ABS, except the doors would arrive with ( CIE «X» ) certification and paper work. Please confirm this is acceptable?

**Answer 1 :** Certification by an IACS member society in lieu of ABS is acceptable as long as all conditions as stated in the SOW (statement of work) are met.
