C. Questions and Answers

Q1: The General Instructions Section 24.2 notes that a Staging areas/truck access roads table in supposed to be including in the tender docs. I do not see this table or any maps showing access points. Do you have this available?

A1: Refer to revised Section 01 11 55 General Instructions for clarity.

Q2: Form 21-0002 Invitation to Tender states a completion date of August 4th 2021 while the tender specification shows June 4th 2021 in the General Instructions note 5.1. Which is correct?

A2: June 4th is an interim completion date for installation of Bridge 74. August 4th is the overall completion date for all works under this Contract.

Q3: Would Parks Canada accept Bid Deposit in the form of a Bank Draft for 50% of the contract value in lieu of the requested Bid Bond. The Bid Deposit could be converted to Performance Guarantee on award of contract.

A3: As per GI08 Bid Security Requirements, the Bidder shall submit bid security with the bid in the form of a bid bond or a security deposit in an amount that is equal to not less than 10 percent of the bid amount. If awarded, as per GC9.2 Types and Amounts of Contract security: A security deposit or an irrevocable standby letter of credit in an amount that is equal to not less than 20 percent of the Contract Amount (excluding applicable tax(es)).
