THE FOLLOWING AMENDMENT TO THE TENDER DOCUMENTS IS EFFECTIVE IMMEDIATELY.
THE AMENDMENT SHALL FORM A PART OF THE CONTRACT DOCUMENTS.

Questions and Answers:

Question 1: Drawing S11 has a note for 'New 7' Radar c/w 1500 mm Pedestal' and says 'install as per Terma Pedestal and radar manufacture instructions'. This would appear to indicate that radar and pedestal are supplied by others. If so than why are we given fabrication details for the pedestal? See dwgs S13 to S18.

Answer 1: The Pedestal is to be fabricated and installed as per drawings provided. The supply and install of the Terma Radar is not included in the scope of this work.

Question 2: Are we to install the above items? There is no mention of install Radar and pedestal in the scope of work in the spec.

Answer 2: Please refer to changes below.

Question 3: Is the cable tray included in this scope?

Answer 3: No, the cable tray is not included in this scope.

Question 4: What finish is required for the structure?

Answer 4: Painting is not required but the entire structure, including grating, railing and pedestal are required to be hot-dipped galvanized.

Question 5: Provide additional information on the requirement for a 20amp outlet to be installed on the radar platform. Where is the panel that will feed this circuit?

Answer 5: The electrical work for the 20A outlet is not included in this scope. As indicated in the drawings, a 254x254x6.4 plate is to be bolted to the vertical angle of the railing on the same side as Duckworth Street.

Statement of Work

I. In the Specifications, section 2.0, delete 2.1.1 and replace with new 2.1.1 to read:

2.1.1 Fabrication of radar platform and pedestal as per drawings, see Appendix A.

II. In the Specifications, section 2.0, delete 2.1.2 and replace with new 2.1.2 to read:

2.1.2 Installation of Radar platform and pedestal on site at the Sir Humphrey Gilbert Building. Secure platform to existing platform legs on building roof. Secure pedestal to platform. See Appendix B.
