1	Please advise if Lead time of 30 weeks ARO will be acceptable for delivery due to current connector supply issues?	The Project understands that delays may be increased due to COVID supply issues. Yes, 30 weeks ARO would be acceptable.
2	For Section 2.3.1 - Assaulter Hub 2.0 is it required in all colours OR any of the listed colours?	Any of the listed colours would be acceptable.
3	For 3.2 - Our Assault Hub 2.0 Protective cover is an overmould which cannot be removed, can you please advise what is meant by removable cover and is that a requirement only for Hub or only for ports?	The intent is that Canada would have the ability to change the protective cover if it breaks, not the entire cable or hub.
4	For 3.4.1- Can you please clarify what are Land warrior batteries?	Defined in the SOW clause 1.5.2.

5	For the environment conditions - Test results are requested as proof of compliance, please advise if the test results need to be from 3rd party lab or internal test report by the manufacturer signed off by the internal engineer is acceptable?	Internal test reports by the manufacturer signed off by the internal engineer is acceptable.
6	We would like to request 2 weeks extension.	Equipment is COTS and there should be sufficient time to bid in the allotted time. No extension.
