1. Title

Invasive Plant Management (IPM) in Prairie National Parks and Historic Sites in AB, SK and MB.

2. Background

Invasive plants are recognized as a serious threat to native ecological communities and biodiversity. According to the International Union for the Conservation of Nature (IUCN), invasive species are the second most significant cause of global extinction following habitat loss (2011).

Invasive plants reduce biodiversity and compromise ecosystem function by out-competing native species, altering nutrient cycling, destabilizing soils and causing erosion, among other impacts (Pimentel et al. 2005, Zedler and Kercher 2004). Climate change may have synergistic effects on invasive plants, altering species distributions and local resilience to invasion (Zavalet and Royval 2002). Prevention and early action activities can prevent infestations before they become un-manageable in scope.

Invasive plants in the Prairie National Parks have been recognized as an important stressor to native biodiversity. Invasive Plant Management Plans or Integrated Pest Management Plans are to be developed, if not already in place, for each park or historic site to mitigate these impacts.

3. Objective

- 3.1. Management, using integrated pest management principals, of priority invasive plants and areas that could be considered vectors of spread within the parks at one or more of the following locations:
 - Elk Island National Park, Alberta
 - Prince Albert National Park, Saskatchewan
 - Grasslands National Park, Saskatchewan
 - Riding Mountain National Park, Manitoba
 - Batoche National Historic Site, Saskatchewan
 - Motherwell Homestead National Historic Site, Saskatchewan
 - Fort Battleford National Historic Site, Saskatchewan
 - Fort Walsh National Historic Site, Saskatchewan

4. Definitions

- **4.1. First and Second Pass:** one or two visits to an invasive plant site to conduct invasive plant treatment.
- **4.2. Inspection:** monitoring by the Parks Canada Agency (PCA) Representative or their designate which determines effectiveness of invasive plant treatment and that the activity complies with all legislative and contractual obligations.
- 4.3. Invasive Plant Treatment: chemically and/or manually treat as necessary to destroy all target plants on site and to prevent viable propagule spread. Propagules refer to reproductive plant parts that may include seeds, stolons, rhizomes, bulbs or stem or root fragments. Treatment should be completed by methodically traversing each site, on foot if necessary, in order to locate, survey, and treat each plant. Invasive plant treatment includes placing and removing

4.4. Management effectiveness Monitoring: a visit to a site to determine treatment compliance and efficacy; occurs the same season as the treatment.

- 4.5. Invasive Plant Treatment Site: an area identified by a UTM coordinate that has target invasive plant species or multiple target species growing within 100 meters of the UTM coordinate. Target species that are greater than 100m from the coordinate are considered part of the original site if the gap between the last occurrence of a target species at the site and the newly found target species is less than 100 meters. A new site is created if there is greater than 100m between the last occurrence of a target species at the original site and another plant of the same target species.
- **4.6.** Invasive Plant Management Area: an area outlined by a clear UTM track or polygon shape file, in which one or multiple invasive plant species are to be managed. One Invasive Plant Management Area may contain multiple Invasive Plant Treatment Sites.
- 4.7. Monitoring: either the initial/baseline visit to a site to determine species presence and relative abundance or a subsequent visit in succeeding years that measures change at that site.
- **4.8. Planting/Seeding:** the action of planting plugs or distributing seeds in a designated area, usually following Invasive Plant Treatment. Is done to promote the growth of desirable species at a site.
- **4.9. Target Species**: invasive plant species specifically listed for treatment.
- 4.10. Treatment Notices: Herbicide Application Signs that are placed at the beginning of any public access route(s) that intersect the site prior to commencing herbicide treatments. Signage requirements will be posted in accordance with specifications laid out in the relevant IPMP or other site-level guidance.
- 4.11. Record of Treatment: Each National Park or Historic Site will have its own methods of record-keeping, either digitally or hardcopy, but same for all is that records of treatment type, chemical used and area treated must be recorded.
