This Amendment #009 is raised to answer bidder questions. Please see responses below.

Q1: In reference to the Tender Document section SC01 item 3, will it be a requirement to obtain approved sub-SRCL's for all subcontractors required to work on the contract?

A1: Should the successful bidder wish to subcontract some of the work under this contract, an SRCL for each subcontract must be sent to the Contract Security Program (CSP). Each subcontracted organization must maintain, at minimum, a Designated Organization Screening (DOS) to perform the work. The DOS status for the subcontracted organization may be substituted by a successful PSOS form submission to the Registration Division, submitted by the Prime Contractor.

Site work by the subcontractor may not commence until acknowledgement and approval by both CSP and PSPC.

Q2: Is the Contractor allowed to use one escort for multiple workers? If so, how many uncleared workers can be escorted under one escort?

A2: The contractor is allowed to use one escort for multiple workers provided the escort is within line of sight contact with the worker(s) at all times. Multiple escorts will be required if workers are spread out and working in different areas thus unable to maintain the line of sight contact. There is no limit to the number of uncleared workers under the surveillance of a single escort as long as the line of sight contact can be maintained.

All other terms and conditions remain unchanged.
