**1. Bidder Questions and Answers:**

Q1. Would you grant a 10 day or 30 day closing date extension?

Q2. Is there any variance allowed in the shade of blue with the coveralls and overalls? Would you accept royal blue coveralls and overalls?

A2: The coveralls and overalls must be navy blue. Royal blue will not be accepted. See amendment to Annex "A" for clarification on colour code.

\*\*Please note that we will not be answering questions during the solicitation period about whether specific images provided by suppliers would meet the colour requirement as it could give suppliers an unfair advantage.
