SI03 OPTIONAL SITE VISIT

It is recommended that the Bidder or a representative of the Bidder visit the work site. Arrangements have been made for the site visit to be held on **TBD**. Interested vendors are to meet in the front lobby of **RCMP Detachment** located at _____.

Only two (2) attendees from each bidder will be allowed to attend the site visit, this includes any of the subs they are requesting to attend, due to the current COVID-19 restrictions. Bidders must notify the Contracting Authority, via email, two (2) days prior to the scheduled visit to confirm attendance and provide the name(s) of the person(s) who will attend, if no notification is provided the site visit will be cancelled. Bidders who do not participate in the visit will not be precluded from submitting a bid. Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation.

- a. The Contractor must, at the Contractor's expense, obtain and maintain insurance contracts in accordance with the requirements of the Certificate of Insurance. Coverage must be placed with an Insurer licensed to carry out business in Canada.
