Solicitation Amendment 001 is being issued to respond to questions received on solicitation No. EA372-210001

QUESTION 1: If an agency doesn't want to change any bids, but still want to be on the contract, do they just have to sign and send back the one form (Annex F Continuation Certification)?

RESPONSE 1: The Continuation Certification form must be submitted if the offeror want to incorporate their past offer information into their offer for this solicitation. The form must be submitted with their offer by the bid closing date and time.

Please refer to Part 2 - Offeror Instructions – on how to submit an offeror.

QUESTION 2: If a company doesn't send this back, would it cancel any existing rates that currently exist?

RESPONSE 2: Yes.

As per Part 4 - Evaluation Procedures and Basis off Selection of the solicitation document - If an Existing Standing Offer Holder whose offer fails to meet any of the criteria's listed under section A. EXISTING STANDING OFFER HOLDERS, the Existing Standing Offer Holder will be deemed non-compliant and non-responsive, and will not be considered any further.

QUESTION 3: Are you able to confirm if this applies to all provinces we currently operate in? i.e. NB, NL and NS?

RESPONSE 3: A separate technical and complete offer must be provided for each Region (i.e. Atlantic Region, Ontario Region, Pacific Region, etc.) where the Offeror wishes to provide services.

QUESTION 4: Can you explain the use of 2015A and 2015B and that 2015B refers to **???**Pilot program**???** as I cannot find any reference to this in the SACC Manual.

RESPONSE 4: 2015B is for Services. This is currently a pilot program and therefore the clauses has not been included in the SACC manual. The Canadian Collaborative Procurement Initiative (CCPI) is part of our ongoing work to modernize procurement practices. Through this initiative, provincial and territorial governments, as well as Municipalities, Academic Institutions, Schools and Hospitals (MASH) sector and other entities, can use federal procurement tools to; meet their buying needs.
