We would like to kindly ask that the NSN be changed for Items 1 & 2 on this bid. We request this because the part number being requested (I-638A4TB) that is currently listed with NSN 4330-20-006-9352 is also listed on NSN 4330-01-482-7909, which lists the exact same part number (I-638A4TB). The reason why we ask for this is that NSN 4330-01-482-7909, also lists the part number we would like to quote as an approved alternate part to the I-638A4TB. Would you be able to help with this change? We believe the National Defense will have many more bids to choose from and will be in the best interest of the National Defense.

Answer 1: The NSN will not be changed. In accordance with the Canadian Forces Technical Orders which is maintenance procedure for Quality Control of Aviation and Ground Fuels and Lubricants (C-82-010-007/TP-000), it is contrary to interchange filters in our vessels.
