1) QUESTION AND RESPONSE

QUESTION 1: Can you explain the use of 2015A and 2015B and that 2015B refers to ???Pilot program??? as I cannot find any reference to this in the SACC Manual.

RESPONSE 1: 2015B is for Services. This is currently a pilot program and therefore the clauses has not been included in the SACC manual. The Canadian Collaborative Procurement Initiative (CCPI) is part of our ongoing work to modernize procurement practices. Through this initiative, provincial and territorial governments, as well as Municipalities, Academic Institutions, Schools and Hospitals (MASH) sector and other entities, can use federal procurement tools to; meet their buying needs.
