**Amendment 002 has been raised to answer the following questions and make the following changes:**

**Question 1:** Under Annex “G” GREENING, ACCESSIBILITY AND SOCIAL COMMITMENTS we have the following questions: can you please elaborate on this initiative and why is this initiative being used?

**Answer 1:** As part of PSPC’s ongoing commitment to social procurement, we have an obligation to consider social initiatives where possible. It was deemed this requirement would benefit from social considerations.

**Question 2:** Under Annex “G” GREENING, ACCESSIBILITY AND SOCIAL COMMITMENTS we have the following questions: can you please explain what the 2 % preferential margin is and how is it applied (it’s not quite clear from the sample). For example, will it be applied to the bill rate and does it include everything that we included in our original bill rate?

**Answer 2:** Please refer to the examples provided at clause 4.1.2.2.3. The 2% is only applied for evaluation purposes. Upon issuance of a Standing Offer, the all-inclusive firm hourly rate will remain unchanged from the offer.

**Question 3:** Under Annex “G” GREENING, ACCESSIBILITY AND SOCIAL COMMITMENTS we have the following questions: is this a mandatory criteria as it’s listed under the Mandatory criteria, but yet it further states that it’s optional.

**Answer 3:** This is not a mandatory criteria. It is optional but offerors are encouraged to participate in this initiative.

**Question 4:** Under Annex “G” GREENING, ACCESSIBILITY AND SOCIAL COMMITMENTS we have the following questions: how is the Green Initiative being evaluated and if we “fail” how will it affect our rates?

**Answer 4:** A 2% preferential margin will be applied for evaluation purposes if your response includes the indicators for assessment as per Annex “G”. If you do not provide these indicators or if your response doesn’t align with our indicators for assessment, you will not receive a 2% preferential margin on your evaluated rate.

**Question 5:** As an Existing Standing Offer Holder, are we only required to submit the “Annex F Continuation Certificate” and offer rates at the website specified on pg. 14, 4.1.2.1 A.1? We are seeking clarification if there are any other submission requirements, other than the ones outlined.

**Answer 5:** The Continuation Certification form must be submitted if the offeror want to incorporate their past offer information into their offer for this solicitation. The form must be submitted with their offer by the bid closing date and time. Please refer to Part 2, 3 and 4 of the RFSO to know how to submit an offer and to know what forms part of your offer.

**Question 6:** PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION: Can you please outline which, if any, certifications and additional information are required at the time of submission for Existing Standing Offer Holders.

**Answer 6:** If you are an existing Standing Offer Holder, you must submit an offer as per Part 2, 3 and 4. Annex “F” forms your technical offer but your financial offer and certifications must be submitted as per Part 3 and 4. Any certifications that apply to you must be submitted with your offer.
