Solicitation Amendment No. 003

Title: Office Furniture, Chairs

(1) This solicitation is hereby amended to provide the following questions and answers:

Q2: In the Additional Criteria section of the Chair Builder form, there is an reference to a "Plastic Inner and Outer frame". Is this in reference to the backrest structure? If so why is the material with which the chair is fabricated matter given this has not effect on functionality (the user does not touch the frame when using the chair) or design (shape, thickness, look are not limited by the material used) of the chair? Would Canada accept a chair with a metal frame?

A2: plastic inner and outer frame is required to fit within the weight limitation.

Q3: In the Additional Criteria section of the Chair Builder form, there is a requirement that the chair's lumbar apex be 4". Would the client accept the standard Government of Canada recommended lumbar range of 2", or a shorter range than the original extreme of 4"?

A3: ESDC have unassigned workstations and every chair need to comply with the ergonomic assessment results. 4" lumbar adjustment is the minimum requirement.

Q4: In the Additional Criteria section of the Chair Builder form, there is an indication that a "5-star base must be available in aluminum:.. Is the intent that an aluminum base must be included in the price of the chairs bid or is it simply that an aluminum base must be made available as an option at contract award or later, at an additional cost. Please confirm if the price bid must include the cost of an aluminum base?

A4: The Additional Criteria must be included in the bid price as amendments after contract award are not permitted.

Q5: In the Additional Criteria section of the Chair Builder form, there is a requirement that the chair must be under 40 lb, can you please confirm.

A5: The weight limitation is a client request on accessibility requirements. Heavy chairs can be difficult to move even with casters. The client currently have an employee in a wheelchair and need a light product to be able to move the chairs easily.
