### Title: Office Furniture

(1) This solicitation is hereby amended to provide the following questions and answers:

**Q11.** In Amendment No. 002 in Table 1E – Product Table Category 6: Collaborative Table (Revised 13 May 2021) there is a request for tables to be 25” High. Can you please confirm as 25” is a non-standard height.

**A11.** GoCuid is actually for 29” H. We will change the height requirement as per GoCuid for this item.

**Q12.** Based on the 2<sup>nd</sup> Floor layout, you are showing a row of 10 Touchdown stations powered by a single Top Feed. Will PWGSC consider using an additional Top Feed at the opposite end of this run of 10?

**A12.** Yes this is acceptable, please make sure that any additional required Top Feed are indicated on a drawing with your bid.

**Q13.** In Table 1B – Product Table Category 5, you are requesting pricing for a total of 234 Desk Lights for “All Open Work Area @ HA Table and Focus Rooms @ HA Table”. Desk Lights aren’t shown on the Touchdown stations. Can PWGSC please confirm the correct quantities and if they are required on the Touchdown stations. Also, since you are asking for pricing in Table 2 - Delivery and Table 3 - Installation by floor number for these Desk Lights, can you please confirm the total count by floor.
