Modification 005

On page 37 of the Solicitation, Annex A – Statement of Requirement, n) Rugged Tablet Regulatory and Environmental Compliance:

Delete in its entirety and replace with:

(i) The ruggedized tablet must be tested to be compliant to the CSA Class II Div 1 Group G, Intrinsically Safe Apparatus and Associated Apparatus certification . Certification must be performed by the Canadian Standards Association (CSA) or through equivalent certificate of conformity (COC) from an approved certification body accepted into the Scheme such as CSA, Labtest or QPS (includes IECEx certification for Zone 20, IIIB). Certification must be completed successfully prior to bid closing. If the certification has been performed by the entities not listed herein the bidder must inform the contract authority during the Q&A process. The contract authority reserves the right to determine CSA equivalency and certification worthiness at that time and will publish that determination through the Q&A process.

- (ii) Solid ingress protection: IEC 60529, IP-6x
- (iii) Liquid ingress protection: IEC 60529, IP-x5
- (iv) Full engineering test reports from an independent test laboratory demonstrating the tablet's notebooks compliance must be included in the bid response.
