1. Respond questions from potential bidders;

Q1: Is it acceptable to supply a 3100rpm engine with a 1.2:1 ratio gearbox to give 2600rpm shaft speed?

A1: Technical Specification revised at Article 12.1.C.11

Revise Technical Specification in response to bidder question: At Article 12.1.C.11:

Delete: Engines must be diesel compression ignition powered, inboard, and have a propeller shaft power rating between 241hp to 291hp, at a maximum rated speed of 2600 RPM.

Insert: Engines must be diesel compression ignition powered, inboard, and have a propeller shaft power rating between 241hp to 291hp.

Q2: Are there drawings available of the existing cardan shaft and couplers?

A2: No unfortunately not, and a part number cannot be read anywhere on the cardan shaft.

Q3: Does the generator require 12V isolated ground system?

A3: Yes.

Q4: Does the propulsion system require a 12V or 24V arrangement?

A4: 12VDC.

Q5: Is there a drawing or information on the existing silencer system?

A5: No drawing. No additional information to provide.

Q6: The standard engine for a 30 kW as a power of 43.5 hp. If the hydraulic is using 42 hp, that will leave no power for AC electrical power. Is the purpose of the hydraulic PTO for emergency crane backup hydraulic power for the crane, or shall the engine be sized for both 30 kW 120/240 VAC and 42hp resulting in a custom made 30 kW genset with a bigger 85 hp engine?

A6: 43.5hp is approved for the bid. With the existing engine there is enough PTO power to operate the crane safely, while having the house loads that need to be on during crane operations.
