PART 1 - GENERAL INFORMATION

1.1 Security Requirements

1. At the date of bid closing, the following conditions must be met:
 - (a) the Bidder must hold a valid organization security clearance as indicated in Part 6 - Resulting Contract Clauses;
 - (b) the Bidder's proposed individuals requiring access to classified or protected information, assets or sensitive work sites must meet the security requirements as indicated in Part 6 - Resulting Contract Clauses;
 - (c) the Bidder must provide the name of all individuals who will require access to classified or protected information, assets or sensitive work sites;
2. For additional information on security requirements, Bidders should refer to the [Contract Security Program](http://www.tpsgc-pwgsc.gc.ca/esc-src/introduction-eng.html) of Public Works and Government Services Canada (<http://www.tpsgc-pwgsc.gc.ca/esc-src/introduction-eng.html>) website.

1.2 Requirement

This is a two (2) Phase competitive process to seek qualified suppliers for an AV Supply and Install project in Ottawa with security level as indicated per attached SRCL and in solicitation Part 6, 6.1 Resulting Contract clauses.

This requirement is subject to a two (2) phase competitive procurement process.

The first phase, phase I, EJ078-220335/A Request for Proposal (RFP) is a qualification process to create a pre-qualified bidders list for phase II. As a result of this phase I RFP, a pre-qualified bidders list will be created.

The second phase, phase II, EJ078-220335/B will be issued to the bidders on the phase I pre-qualified bidders list to Request for Proposal (RFP) of an AV Supply and Install project consisting of a scope of work that includes equipment, engineering, design, project management, fabrication, assembly, software programming, installation, documentation, training and warranty of the audiovisual systems. All specifications drawings and details will be sent to the qualified bidders from the Phase 1 competitive process. Note some drawings may only be available by appointment at a designated location for RFP EJ078-220335/B.

1.2.1 Delivery Requirement – Second Phase, Phase II

Delivery for the Second Phase, Phase II RFP EJ078-220335/B, Equipment only, must be delivered by March 31, 2022. Installation is estimated to be in the June to December 2022 timeframe.

1.3 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1.4 Phased Bid Compliance Process

The Phased Bid Compliance Process will apply to the Second Phase, Phase II RFP EJ078-220335/B for this requirement.

1.5 epost Connect service

This bid solicitation allows bidders to use the epost Connect service provided by Canada Post Corporation to transmit their bid electronically. Bidders must refer to Part 2 entitled Bidder Instructions, and Part 3 entitled Bid Preparation Instructions, of the bid solicitation, for further information.

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract. (The first phase, phase I, EJ078-220335/A Request for Proposal (RFP) is a qualification process to create a pre-qualified bidders list for phase II. As a result of this phase I RFP, a pre-qualified bidders list will be created. A resulting contract will be determined from the second phase, phase II solicitation EJ078-220335/B)

The [2003](#) (2020-05-28) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

2.2 Submission of Bids

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated in the bid solicitation. Do not send proposal directly to the Contracting Officer.

Note: For bidders choosing to submit using epost Connect for bids closing at the Bid Receiving Unit in the National Capital Region (NCR) the email address is: tpsgc.dgareceptiondessoumissions-abbidreceiving.pwgsc@tpsgc-pwgsc.gc.ca

Note: Bids will not be accepted if emailed directly to this email address. This email address is to be used to open an epost Connect conversation, as detailed in Standard Instructions [2003](#), or to send bids through an epost Connect message if the bidder is using its own licensing agreement for epost Connect.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than seven (7) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

2.5 Bid Challenge and Recourse Mechanisms

(a) Several mechanisms are available to potential suppliers to challenge aspects of the procurement process up to and including contract award.

(b) Canada encourages suppliers to first bring their concerns to the attention of the Contracting Authority. Canada's Buy and Sell website, under the heading "Bid Challenge and Recourse Mechanisms" contains information on potential complaint bodies such as:

- Office of the Procurement Ombudsman (OPO)
- Canadian International Trade Tribunal (CITT)

(c) Suppliers should note that there are **strict deadlines** for filing complaints, and the time periods vary depending on the complaint body in question. Suppliers should therefore act quickly when they want to challenge any aspect of the procurement process.

3.1 Bid Preparation Instructions

Section I: Technical Bid

In their technical bid, Bidders should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work.

For this Phase, Part 1, Phase 1 RFP EJ078-220335/A the technical information **must** include the requirements noted in: 4.1.2.1 Mandatory Technical Criteria

3.1.1 Exchange Rate Fluctuation

The requirement does not offer exchange rate fluctuation risk mitigation. Requests for exchange rate fluctuation risk mitigation will not be considered. All bids including such provision will render the bid non-responsive.

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

4.1 Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the **Technical and Security evaluation criteria**.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.
- (c) Canada will use the Phased Bid Compliance Process (Applicable to the second phase, phase II solicitation).

4.1.1 Phased Bid Compliance Process

4.1.1.1 (2018-07-19) General

The Phased Bid Compliance Process is part of the second phase, phase II RFP EJ078-220335/B. Full details and clauses of the PBCP will be included in the Second Phase, Phase II RFP

4.1.2 Technical Evaluation

4.1.2.1 Mandatory Technical Criteria

The following Mandatory requirements must be submitted with the bid for evaluation for this First Phase 1, Phase 1 RFP

- Demonstrate a minimum of 5 years' experience implementing and installing secure videoconferencing and presentation systems in secure environments.
- List 2 AV projects delivered in Canada where the total contract value exceeded 1.5M completed within the last 5 years. Details to include client and project scope including partnered manufacturers used to deliver the solution. Reference Contact.
- List 2 Projects completed in the past 3 years where AV over IP technology has been implemented. Provide project summary and scope as it relates to AV over IP and reference contact if different than above listed projects.
- hold SECRET level clearance. Must retain full time staff holding active SECRET level clearance including: Senior Installer, Project Manager, Systems Programmer (Audio and Video Control Systems) and Engineer.

4.2. Basis of Selection

4.2.1 A bidder must comply with the requirements of the First Phase, Phase I Request for Proposal EJ078-220335/A and meet all mandatory technical evaluation criteria at 4.1.2.1 - Mandatory Technical Criteria and Security requirements as per attached SRCL and Security Classification Guide to be declared responsive.

4.2.2 All responsive First Phase, Phase I bidders will qualify for the Second Phase, Phase II RFP EJ078-220335/B and be issued the Request for Proposal for an AV Supply and Install project consisting of a scope of work that includes equipment, engineering, design, project management, fabrication, assembly, software programming, installation, documentation, training and warranty of the audiovisual systems. The second phase RFP EJ078-220335/B will not be published on Buy and Sell.

PART 6 - RESULTING CONTRACT CLAUSES

The following clauses and conditions apply to and form part of any contract resulting from the bid solicitation.

6.1 Security Requirements

6.1.1 The following security requirements (SRCL and related clauses provided by the Contract Security Program) apply and form part of the Contract.

 - (b) *Contract Security Manual* (Latest Edition).
