Solicitation Amendment #1 is issued to answer a potential bidder's question and to clarify information for Submission of bids.

Question: Our company has on-boarded sub-contractors for our large enterprise clients strewn across Canada in every major city in every province. Are these sub-contractors that we have hired as full-time contractors, compliant with Phase I of this solicitation if they meet all the security requirements stated within the document?

Answer: Yes, sub-contractors may be used for portions of the project. All certifications regardless of the persons employment location must be submitted with the bid as per Part 3, Section III: Certifications. Any expenses relating to travel must be handled by the bidder.

Bid Submission clarification:

Given that many people are currently working from home and in an effort to reduce the spread of the coronavirus disease (COVID-19) within communities, bidders are highly encouraged to transmit their bid electronically using the epost Connect service. Information on the epost Connect service can be found in Part 2 entitled Bidder Instructions, and Part 3 entitled Bid Preparation Instructions, of the bid solicitation.

3.1 Bid Preparation Instructions

- When the Bidder submits its bid electronically, Canada requests that the Bidder submits its bid in accordance with section 08 of the 2003 standard instructions. The epost Connect system has a limit of 1GB per single message posted and a limit of 20GB per conversation.

The bid must be gathered per section and separated as follows:

- Section I: Technical Bid
- Section III: Certifications (Security Clearance levels - refer SRCL (Security Requirements Check) List and section 1.1 Security Requirements in Part 1 and Section 6.1 Security Requirements in Part 6 and the Security Classification Guide)

Add the following information to: 3.1 Bid Preparation Instructions

- If the Bidder chooses to submit its bid in hard copies, Canada requests that the Bidder submits its bid in separately bound sections as follows:
 - Section I: Technical Bid (3 hard copies) and 3 soft copies on a USB key
 - Section III: Certifications (3 hard copies) and 3 soft copies on a USB key

If there is a discrepancy between the wording of the soft copy on electronic media and the hard copy, the wording of the hard copy will have priority over the wording of the soft copy.

- If the Bidder is simultaneously providing copies of its bid using multiple acceptable delivery methods, and if there is a discrepancy between the wording of any of these copies and the electronic copy provided through epost Connect service, the wording of the electronic copy provided through epost Connect service will have priority over the wording of the other copies.

All other terms and Conditions remain the same
