Question 2: On May 31, 2021 solicitation 47419-211699/A was published to Buy & Sell with the cover page of the RFP indicating a closing date of July 5, 2021. Today (June 1, 2021) amendment 1 was published and the closing date on the amendment indicates a closing date of June 21, 2021.

Given the level of effort to respond to a solicitation of this magnitude, particularly for vendors looking to respond to multiple workstreams, can the Crown please confirm that the closing date is July 5, 2021 as indicated on the original publication of this solicitation?

Answer 2: Similar question has been raised by few bidders. Therefore, this question will only be published once. An error with the system happened when publishing the original solicitation on May 31, 2021.
