Responses to Questions from Bidders

Q1. I have been unable to reach one of the First Nation's representatives listed in the IPR. What are my options?

A1. The bid requirements associated with the Indigenous Participation Requirement (IPR) will not change if you're unsuccessful in making contact with one of the Nations. Multiple representatives spanning multiple First Nations are listed in the IPR. Refer to Appendix 5 – Mandatory Qualification and Indigenous Participation Requirement (IPR) form, Part 2 - 2) Engagement with First Nations.

Q2. I noticed the signature line for the First Nation's representative has been removed from the IPR (previously IBP). What are the new requirements for ensuring a successful IPR?

A2. Engagement with the Nation(s) is still required in order to develop the IPR for bid submission. As per SC04 - Terms of Payment, the successful contractor must submit a completed and up-to-date cumulative Indigenous Participation Requirement report with any payment claim. Failure to meet the minimum IPR value will be subject to SC03 – Performance Evaluation: Contract.
