Title: Cemetery Maintenance for British Columbia

1. This solicitation is hereby amended to respond to the following questions:

Question 1:

On the list of repairs, the term “alignment” in English and “alignement” (put to level) in French is used. Does this refer to one monument or a row of multiple monuments? What work is required for the “alignment” of monuments?

Answer 1:

Attachment 5 indicates the number and type of markers that need to be repaired in each cemetery. They may be grouped side by side or individually spread throughout. Flat markers are to be levelled to surface of the ground and aligned with other markers in that same row. Individual Upright markers are to be levelled so they are vertical and aligned with other markers in that same row. Technical specifications can be found in Attachment 1 – National Technical Maintenance Manual - Section 4.
