AMENDMENT #003

This amendment is issued to modify Annex A - Overview and High Level Description of Requirement.

MODIFICATION 002:

Section 8.3.10 - Identity and Access Management of Annex A -Overview and High Level Description of Requirement is hereby deleted in its entirety and is replaced with the following Section:

Section 8.3.10 -- Identity and Access Management

The Contractor must ensure adequate protection of the account management process used to deliver and support the Services for Canada. Security measures must include, but are not limited to:

- 1) Providing Master Account privileges solely to Canada personnel in such a way that the Contractor relinquishes all control of the service to Canada OR
- 2) Where Contractor personnel are required or desired to have access to the Master account, the Contractor must:
 - a) Provide RCMP Security Operations personnel with notification of the creation or use of any privileged account, including the Master account
 - b) Limit access to only RCMP cleared and authorized users who are permitted by Canada to execute transactions and functions such as Master account creation and issuance;
 - c) Ensure the separation of duties of individuals;
 - d) Employ the principle of least privilege, including for specific security functions and privileged accounts;
 - e) Ensure that authorized users are provided with security awareness and training as part of employment onboarding and when their roles change;
 - f) Create, protect and retain audit records related to the activities that support account management of Services provided to Canada;
 - g) Provide Canada with reports on audited events for actions related to the issuance and management of Master accounts; and
 - h) Ensure that Organizational Data is protected during and after personnel actions such as terminations and transfers.

ALL OTHER TERMS AND CONDITIONS REMAIN THE SAME
