1. Questions:

Question 22: We understand that CBSA has immediate operational needs, however due to the large amount of time and effort required to complete a response for this RFP, particularly if Bidders are responding to all Workstreams, would CBSA kindly provide an extension to June 25, 2021 to give Bidders the additional time needed to complete a quality response?
