Instructions:

- 1) All values are required to be in Canadian dollars;
- 2) Bidder is required to enter applicable costs to Canada in the table, which must include applicable mark-ups, fees, profit, etc.... such that the entries reflect the costs that would be charged to Canada;
- 3) All entries must exclude federal and provincial taxes;**
- 4) The Bidder is not required to complete Appendix I – Pricing Schedule of the RFP;
- 5) Administrative services component of the Management Fee could include but not be limited to costs for administrative personnel, licensing agreements, etc... as determined to be necessary by the bidder based on the requirements of Annex A, Statement of Work;
- 6) For the purposes of Appendix I – Pricing Schedule, the costs identified by the Bidder for Years 1 to 6 for Items 1 and 2 will be divided by 12 to arrive at a per monthly firm fixed cost for the applicable year;
- 7) For the purposes of Appendix I – Pricing Schedule, the costs identified by the Bidder for Years 1 to 6 for Items 3 to 10 will be divided by 230 days to arrive at a daily rate for the applicable year. While it is anticipated that this effort will be utilized, only those actual days or a portion of a day worked by the proposed resources for these categories can be charged to Canada. A day is considered 8 working hours;
- 8) For the purposes of Appendix I – Pricing Schedule, only the percentage identified by the Bidder for Years 1 to 6 for Items 11 and 12 will be reflected. The value identified above is an estimated value only. For the purposes of the evaluation, the percentage identified by the Bidder will be multiplied by the estimated dollar value identified for these line items to determine the total applicable mark-up cost. This cost will be captured as part of the total bid price for the purposes of bid evaluation;
- 9) For the purposes of Appendix I – Pricing Schedule, the price per year identified by the Bidder for Years 1 to 6 for Item 13 will be divided by the estimated hours to arrive at a per hour rate. The hours identified are only an estimated level of effort.
