**1. Questions:**

**Question 36:** The table provided on Page 119 of 120 of the PDF version of the RFP (pasted in full below) does not appear to fit with any of the mandatory or corporate criteria. Can the Crown please confirm that this table was provided in error and does not need to be used in response to this RFP?

**Answer 36:** The Table is provided to assist Bidders in structuring the required information. Bidders may choose to use the Table but it is not required.

**Question 37:** There is a table on page 119 of the RFP that seems to be looking for numbers of resources simultaneously managed for a one-year period across three contracts. This table doesn't seem to relate to any of the requirements in this RFP. Please confirm that Bidders can ignore this table

**Answer 37 :** see response at Q&A 36.

**Question 38:** This question is made as a follow-up to Question & Answer 33. While it is appreciated that the solicitation number located in solicitation pages 119 and 120 was clarified in Answer 33, as it stands this solicitation still includes the table on page 119, which is not referenced to by any of the requirements or instructions within this solicitation. As pointed out in Question 33, this table existed in Correctional Services Canada solicitation 21120-194545/A for the purpose of demonstrating Account Manager experience managing multiple contracts with a certain number of simultaneous resources. This requirement does not exist in 47419-211699/A – the current solicitation.

Respectfully, Bidders need an explanation on the purpose of the table on page 119 of the solicitation in order to submit a compliant bid response, as there are currently no instructions or RFP requirements explaining the purpose of the table and specifically what Bidders must enter into it in order for their response to be deemed compliant. Will the Crown please clarify whether this table will be removed from the solicitation and if not, identify where in the solicitation there are instructions or requirements referencing this table?
