1. Revise Bidder's Conference Information.

At Article 2.5 Bidders' Conference in the ITT document:

Delete: In its entirety

Insert:

A virtual bidder's conference chaired by the Contracting Authority will be held on **Monday June 28, 2021 at 12:00 PM EST (National Capital Region (NCR) time)**. The scope of the requirement outlined in the solicitation will be reviewed during the conferences and questions will be answered. It is recommended that bidders who intend to submit a bid attend or have representation attend. It will be assumed that the bidders attending the bidders conference have read the specification included in Annex A, and are prepared for the conference.

Bidders are requested to communicate with the CA before the conference to confirm attendance (virtual meeting details shall be sent to participants). Bidders should provide by email to Jessica.Blackburn@tpsgc-pwgsc.gc.ca the names of the person(s) who will be attending and a list of issues they wish to table, no later than three (3) business days before the scheduled Conferences.

Any clarifications or changes to the solicitation resulting from the Bidder's Conference will be included as an amendment to the solicitation.

Bidders who do not attend will not be precluded from submitting a bid.

2. Amend Clause in ITT document due to Vendor Question.

At Article 6.8 ISO 9001:2008 - Quality Management Systems

Delete:

The Bidder shall have in place a Quality Management System registered to ISO 9001:2008 and shall provide, at time of bid closing:

- Valid ISO 9001-2008 certification.

Insert:

The Bidder must have in place a Quality Management System registered to ISO 9001:2015 (or latest version) or a Quality Management System modeled on ISO 9001:2015 (or latest version).

Documentation and procedures of bidders not registered to the ISO standards may be subject to a Quality System Evaluation (QSE) by the Technical Authority or designate before award of a contract.

Contractors prior to contract award will be required to provide a copy of their QA manual as well as copies of QA reports from previous projects completed.

3. Respond to Vendor Questions.

Question1. In the following statement: "For alternate engines and gearboxes, cost must include replacing the Caterpillar C-12 and Twin Disc MGX5114RV gearboxes already fitted to the five existing vessels, training of two (2) crew members per vessel on the proposed propulsions system", this would indicate that these 5 vessels that currently have C-12 engines, have no intention of being part of the VLE. In the Tender document, Paragraph 2.7 clearly shows that all 36 vessels are scheduled for a VLE, and therefore would include the 5 vessels that were originally equipped with C-12 engines. These facts are therefore contradictory. Can you clarify if all 36 vessels are intended to go through a complete VLE and therefore have the engines replaced? If so, this statement should be removed as it would be redundant.

Response1: All 36 vessels are intended to go through VLE, 31 will have the currently fitted 3196 engines replaced. The 5 vessels currently fitted with C12s will have the engines rebuilt instead of replacing them, unless an alternate engine is selected. In that case those engines must be replaced as well. Specification item M-53 1.2 states "The intent of this specification is to remove the existing Caterpillar 3196 engines, gearboxes, controls and monitoring systems and to replace with new contractor supplied Caterpillar C-12 diesel marine propulsion engines, gearboxes, controls and monitoring systems."

From the standpoint of CG, these vessels are a class, and therefore must maintain the same equipment across the fleet. If alternate engines and gearboxes are chosen (alternate to CAT C12 and Twin Disc MGX5114RV) they must be applied to the entire fleet of 36 vessels.

The five vessels currently fitted with CAT C12 engines are located:

- One (1) in Ontario
- One (1) in Quebec
- Three (3) in British Columbia

These engines and gearboxes will be rebuilt, not replaced, unless an alternate package is chosen.

Q2: The following statement: "replacement of existing spares inventory (for bid purposes use \$30,000 per vessel)" needs further explanation. In 31 of the vessels that are currently powered with 3196 engines and 2 different TwinDisc gearboxes, none of the spares that CCG might currently have in inventory would be applicable for any vessel after the VLE is complete. New spares would have to be procured regardless of whether the shipyard chose to use a C12/MGX package, or a package from an alternate supplier. Therefore, this statement is redundant, and should be removed.

R2: The CAT 3196 shares many parts with the C12, therefore much of the existing vessel spare parts inventory will remain valid. If engine and gearbox manufacturer are changed, the entire spare parts inventory for each vessel will become obsolete and must be replaced.

Q3. The following statement: "repopulating the Cape Class Maximo maintenance management system (for bid purposes use \$10,000 per vessel)" also falls into the same point as the previous question. Since the complete propulsion system is being replaced, the Cape Class Maximo system would need to be updated with all of the new Part Numbers, Installation/Warranty Start Dates, Serial Numbers, etc, of the new equipment, regardless of whether the shipyard chose to use the C12/MGX package, or a package from another supplier. This system update will be a requirement for the CCG as part of this VLE. This statement is redundant, and should be removed.

R3: As the CAT C12 is an updated version of the CAT 3196, much of the maintenance schedule / intervals will remain the same. It is true that certain part numbers, serial numbers will have to be updated with the new equipment, but will not require the entire re-working of each job description within Maximo. It is worth noting that Maximo also serves as an inventory management system for the vessels.

Q4: We have a question surrounding the ISO 9001 registration requirement mentioned in sections 6.8, 7.19, J1-14, and M5. While we have a quality system that meets the ISO 9001 standard we are not registered with ISO. The wording in sections 6.8 and J1-14 would preclude us from submitting a proposal. We also note that in section M5 of the Mandatory Technical requirements, there is provision for alternate information to be submitted if a company is not ISO 9001 registered. We are asking if the requirement for ISO certification can be removed from 6.8 and J1-14 and have section 7.19 and M5 be the requirement for a quality system?"

R4: See points 2. (Amend Clause in ITT document due to Vendor Question) and 4.(Provide Revised Annex J – Deliverables and Certificates) of this Amendment 004 to ITT.

Q5: In regards to Specification Item # H-21, can the technical authority provide seating requirements as specification instead of a single supplier's unique configuration numbers, to allow additional suppliers to show equivalency based on requirements?

Why is the replacement of the bridge shock seats (Spec. Item # H-21) sole sourced? The current specification excludes all other manufacturers from competing for the program.

R5: Canada has trialed multiple versions of shock mitigating seats from different manufacturers and conducted an acceleration study of the effects on vessel operators. In order to maintain commonality with seats fitted on other classes of vessels within the fleet, Canada will insist on the shockwave model as specified.
