Amendment **002** is raised to publish questions and answers and modify the solicitation as follows:

1. Questions and Answers:

Question 01: CAT 6A, items #2, #3, would a laminate table be acceptable as well as wood veneer?

Answer 01: Not, at this time.

Question 02: CAT 6B – Item 1: Would the client accept polymer barstool instead of laminate GoCUID 6KBSBHxxLY15XXXRIYX considering all other criteria are met?

Answer 02: GoCUID 6KBSBHxxLY15XXXRIYX is accepted as well as the alternative polymer material.

Question 03: CAT 6C – Item 3. Sketch does not show a corner end table and length A range is calculated without the corner end table. Length A range should be larger if the end unit corner table is included otherwise the seating pieces will not be equal in size on side A and side B. You are showing 3x pieces on each side so length A has to be equal to length B to have all pieces match in size.

Answer 03: Please see written lengths for side A and side B within the 'description of product'. The drawing is a reference tool to illustrate the desired configuration.

As per attached amendment all tables will be square for item 3 & 4.

Question 04: CAT 6C – Item 4. Sketch does not show a corner end table and length A range is calculated without the corner end table. Length A range should be larger if the end unit corner table is included otherwise the seating pieces will not be equal in size on side A and side B.

Answer 04: Please see written lengths for side A and side B within the 'description of product'. The drawing is a reference tool to illustrate the desired configuration.

As per the amendment all tables will be square for item 3 & 4.

Question 05: CAT 6C Item 3 & 4 please confirm if the corner table to be with power or not.

Answer 05: As per modular soft seating requirements, side table to have power and data.

Question 06: CAT 6C – Item 5 would the client accept a standard centre base instead of a C-shape considering all other criteria are met?

Answer 06: Lap Top table to be C shape only

Question 07: Category 6C, item #3, GoCUID# states that the rectilinear bench does NOT have a back, however the description states to have backrest. Could you please clarify if 6G is to have or not have a backrest

Answer 07: As per the written specs, the rectilinear bench unit must be available with a back or not. For this solicitation, a medium height back is required.

Question 08: Category 6C, item #3 and #4, would it be possible for you to confirm is 6F on the drawing represents the attached side table and if 6G is the modular rectilinear benching? Or is 6F and 6G both benching? If that is the case, could you please identify where the tables are to be located?

Answer 08: 6F represents the attached side table within a benching application context, and 6G is the seat with bolster/low to medium back. Item #3 image requires there to be one table in the corner, and 1 on each end (3 total) with seats in between. Item #4 image requires one table in the corner only. The tables in corner are to be square, and the ends can be manufacturer standards.

Question 09: Category 6C, item #7, would the customer accept an integrated surface along the backside of 6F and 6G? This would mean that the backrest on the benching would be a high back. Please confirm.

Answer 09: Yes, an integrated table with a high back seat is acceptable. Length of table must match overall length of the seating. In case where modular seating high back is not available, narrow side table (tag 6T) is to have a full modesty.

Question 10: Cat 6A item 5, will the Client also respectfully accept a laminate, painted MDF, or wood veneer top?

Answer 10: No, the table must be back painted glass.

Question 11: Cat 6B item 1, will the Client also respectfully accept a chair without an armrest or a poly chair on a sled base?

Answer 11: Armrests are required. Polymer chair with sled base is acceptable, as long as it maintains a seat cushion and everything else matches the description in the GOCUID provided.

Question 12: Specific to Cat 6C items 3 and 4 - The GoCUIDs provided are not clear and do not necessarily correspond with the layouts, math, or quantities when SA specifications are adhered to

Answer 12: Please refer to answer A08 and A15.

Question 13: Specific to Cat 6C items 3 and 4. According to the SA specifications, the dimension of the side table is required to be 26" +/- 2" and seating is to be between 25" to 39"w.

Answer 13: Please refer to A08.

Question 14: Specific to Cat 6C items 3 and 4 - Given there is no GoCUID for a side table only in the modular benching, this must be included as a unit with the seating. Noted in blue is item 6F, we believe this should be a unit consisting of a seat plus a table (T indicates what we believe is the table portion).

Answer 14: Please refer to answer A07, A08 and A15.

Question 15: Specific to Cat 6C items 3 and 4 - 6G quantities could be different from the total shown in the RFB sketch given the range of 25" to 39". Please allow bidders to offer their standard dimensions as long as the overall layout and dimensional requirements are met.

Answer 15: Yes, the quantities may differ from the solicitation, as long as bidder match overall dimensions utilizing their product line standard dimensions.

Question 16: Specific to Cat 6C items 3 and 4 -6SMPRBXXLU25G19LNNN is described in the CST as not having a back, but the description in the bid includes a backrest. Please clarify what is required.

Answer 16: Please refer to answer A07.



