### **1. Bidder's Experience - GC**

Each Bidder must meet the following criteria:

- Been in business and provided construction services during the past ten (10) years.
- Completed two (2) similar marine construction projects in the role of General Contractor (GC) within the past five (5) years. A similar project is defined as a new marine construction or addition of similar size successfully completed by the General Contractor.
- Project Manager's experience in marine infrastructure projects (minimum of 10 years)
- Site Supervisor's experience coordinating and overseeing marine infrastructure projects (minimum of 5 years)

### **Contractor's Comparable Work Experience**

The Contractor must provide in their proposal a detailed list of projects undertaken in the past five (5) years. At least two (2) of the projects described must be comparable to the activities contemplated by the Scope of Work of this project. The described comparable work experience must include the following information:

- Project Name
- Detailed written description of the scope of work undertaken
- Contractor's role
- Project location
- For whom the project was performed
- Value of the project (in CAD) including value of any change orders at the start and end date of project
