AMENDMENT 002: W6399-22CA23/A Amendment 002 is being issued to respond to questions from suppliers.

REFERENCE: Annex A, Section 2.3 Requirements – Date Changes

Q1: Can you confirm that any cancellations made within 2 weeks of arrival will be charged as per the terms of the most recent amendment provided 2 weeks or further from arrival and that there isn't a separate cancellation policy?

A1 DND will be able to make cancellations at no cost, of the entire requirement in part, up to 7 days before the service start date. Within 7 calendar days of the start of service either the full cost for any unused accommodations and parking will be paid, or in the event the contract is terminated for Convenience of Canada costs assigned to the Contractor will be calculated as per General Conditions 2010C (2020-05-28) General Conditions – Services (Medium Complexity) Section 22 Termination for Convenience.

DELETE: “There may be changes to the dates or rooms required. The Contractor will be notified of these changes at least two weeks prior to check-in dates. If the Contractor can accommodate these changes a contract Amendment will be issued to include these changes.”

INSERT: “There may be changes to the dates or rooms required. The Contractor will be notified of these changes at least two weeks prior to check-in dates. If the Contractor can accommodate these changes a contract Amendment will be issued to include these changes. DND may cancel the requirement at no cost, in whole or in part, up to 7 calendar days before the start of services.”

REFERENCE: Annex A, Section 3.2.16 Deliverables - Parking

Q2: Can you confirm if the parking requirements are intended for guests of the hotel or vehicles belonging to individuals not staying overnight at the hotel? Are they standard size vehicles?

A2: Vehicles are for guests of the hotel and are standard sized vehicles.

Q3: Can I ask what the nature of the group's stay at CFB Esquimalt is?

A3: Training.

REFERENCE: Annex A, Section 3.1 – Distance Requirement

Q4: The RFP has a mandatory distance from CFB Esquimalt of 5kms. We are 5.7kms away. Will a bid from us be accepted for consideration?

A4: The 5km requirement is based on the vicinity to training facilities, accommodations, amenities, and the distance DND members will be required to travel. We cannot consider any

accommodations further than 5km away. See Q5 below for clarified center point of the 5km radius.

Q5: We have a question about the location of the CFB for this bid. Are these two different places?

- CFB Esquimalt (Work Point Barracks) IVO Peters St
- CFB ESQUIMALT

If possible please provide the full address.

A5: The Work Point Barracks is located on the grounds of CFB Esquimalt. The location used to measure whether accommodations are within 5 km is the corner of Peters Street and Gault Crescent, Esquimalt, British Columbia.

DELETE: "The Contractor's accommodations must be located no more than five (5) kilometers from CFB Esquimalt (Work Point Barracks) IVO Peters St."

INSERT: "The Contractor's accommodations must be located no more than five (5) kilometers from CFB Esquimalt (Work Point Barracks), measured from the corner of Peters Street and Gault Crescent, Esquimalt, British Columbia."

REFERENCE: Part 4, Section 4.1.1 MTC1

DELETE: "The location of the accommodations must be located within a five (5) kilometer radius from FB Esquimalt (Workpoint Barracks), IVO Peters St."

INSERT: "The location of the accommodations must be located within a five (5) kilometer radius from FB Esquimalt (Workpoint Barracks), measured from the corner of Peters Street and Gault Crescent, Esquimalt, British Columbia."

REFERENCE: Annex A, Section 5.0 Optional Services

Q6: For the "Optional Services", "DND may have a requirement for additional accommodations with the same requirements as above before March 31st 2022. The contractor grants to Canada the irrevocable right to acquire the additional services under the same conditions and prices stated in the Contract. If multiple contracts have been issued and a single contract holder is unable to meet the optional requirement the optional requirement may be split between two or more contract holders."

Does this mean that the Contractor needs to have the total # of rooms available at all times or is this more a guarantee that the price can be booked again with the same conditions ? Will the Client have a First Right of Refusal if the hotel is fully booked for the time of this additional request ?

A6: The Contractor will not be required to have the total required number of rooms available at all times until March 31st 2022. If DND has a requirement for further accommodations on or before March 31st 2022 the contractor, if they have availability for the dates requested by DND, will be required to accept the rates provided in Annex B. There is no ordering or selection process for choosing which contract holder will be requested to meet an optional requirement. If there are multiple contract holders as a result of this solicitation process DND will determine which Contractor, or Contractors, will be approached first to fulfill the optional requirement.
