163	Would the Government please confirm that bidder's are to return the Annex J table with question response page numbers populated? If this is correct, could the Government please re-release Annex J, fully updated with all Amendment edits?	No. Canada will not re-release an updated Annex J. As with all other sections of the RFP, the changes raised in the amendments must be considered by suppliers in responding to the requirements of Annex J.
164	In section 7.21 Basis of Payment: Optional Phase 2- Milestone Payments, Subject to holdback- Implementation of Solution (Ref. Table 3 and Table Schedule of Milestone Payments Implementation Support of Annex B, Basis of Payment states a holdback of 10% and further in Section 7.23 Invoicing (c) Invoicing Instructions – Release of Holdback and Balance of Amount Payable. Would Canada agree to release the holdback amounts on a quarterly basis for milestones that were completed and invoiced in the previous quarter. For example, holdback amounts applicable to milestone payments invoiced in the January to March period would be released 3 months later, on June 30th.	No. The hold-back release provision of the resulting contract remains unchanged. The holdback is released on satisfactory completion of all work that are subject to a milestone payment under the resulting contract.
