## SOLICITATION AMENDMENT 002

The purpose of this amendment is to answer solicitation questions and to amend the solicitation document in consequence.

### **Questions and answers:**

**Question 2)** I have question regarding page 11 of solicitation C1111-200211/A - the requirements for M2 have contradictory information, stating "At least five (3) of the projects must reflect experience in working with racialized, religious minority and/or Indigenous organizations." Which is the correct minimum? Should all five examples reflect experience in working with racialized, religious minority or Indigenous organizations, or three of five?

Answer 2) Thank you for your interest in Canadian Heritage's Public Education and Awareness Anti-Racism Campaign.

Through the linguistic review of the RFP, it seems there was an oversight. Regarding page 11 of solicitation C1111-200211/A - the requirements for M2 is to present 5 examples of past work and out of those 5 projects, 3 out 5 should be projects that reflect experience in working with racialized, religious minority and/or Indigenous organizations.

In **PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION**, **DELETE** the following:

EXPERIENCE OF THE BIDDER The Bidder must have a minimum experience of five (5) projects in which they organized consultations. At least five (3) of the projects must reflect experience in working with racialized, religious minority and/or Indigenous organizations.

### **REPLACE WITH**

EXPERIENCE OF THE BIDDER The Bidder must have a minimum experience of five (5) projects in which they organized consultations. At least **three** (3) of the projects must reflect experience in working with racialized, religious minority and/or Indigenous organizations.
