| 9 | Section 3.1.2 includes two SACC manual clauses – C3010T which provides for bidders to be protected against exchange rate fluctuation by Canada and C3011T which specifies that no exchange rate protection is being offered. There seems to be a conflict here and one needs to be deleted. | Delete SACC C3011T. |
| 10 | Section 3.1.1 specifies that bidders are to complete Annex C. Annex C has not been included. Can we please have clarification? | See page 27 of 91 of the solicitation. |
| 11 | Section 4.3.2 indicates that the Financial evaluation will be based on the prices provided in Annex C. This should be Annex B, is it safe to assume this is a typo? | Correct, should be Annex B. |
| 12 | Section 8.1.1 Will Canada accept a company quality management system that is compliant with ISO 9001 requirements as an alternative to a ISO 9001 certification? To demonstrate compliance, the company must provide a copy of their Quality Manual with their bid response. | Department of National defence is not a certification authority of ISO 9001. We are unable to evaluate compliance without official certification. |
