## Annex A-1

- Q1. The MT-5 criteria for the Waste Management Specialist includes a requirement to possess a degree from a recognized university in science, engineering, or business with a specialization in chemistry, waste management, waste logistics, or a related field. In trying to find a waste management expert for the proposed study, we have identified a few individuals with over 20 years of experience running organizations that manage hazardous wastes, including individuals that have founded and greatly expanded businesses that focus entirely on the management and disposition of hazardous wastes in Canada. They do not have these specific university degrees. We would prefer to prioritize knowledge and experience in the field within Canada over a specific university degree that may have no bearing on the study. We would therefore appreciate it if Transport Canada could expand the MT5 criteria to include any university degree so that we can bring this knowledge and experience to bear in our proposal instead of trying to find a junior or inexperienced individual with the desired university degree.
- A1. The intention of including the Waste Management Specialist team member is to provide knowledge on the movement of dangerous goods waste in Canada. As there are no specific university degrees related to this area, we are able to accept another degree (i.e. engineering, chemistry, waste management etc., or related field) as long as the bidder can demonstrate through project summaries that the proposed resource has two (2) years' experience (within the period from March 31, 2010 to April 1, 2020) in the field of waste management, waste logistics, or a related field.
- **Q2.** Can Transport Canada advise what dollar amount has been budgeted for this scope of work?
- **A2.** Transport Canada anticipates the study to start in mid-August 2021 and conclude at the end of March 2022. As part of the bidder's proposal, it is required to submit a work plan identifying the timelines, activities and schedules to meet the stated deliverables. We anticipate that the dollar amount would range between \$120,000 and \$150,000 excluding taxes.
