Each hour worked beyond the 7.5 hours/day will be paid at a single rate of: 1 hour worked = 1 hour charged/deducted.

Minor changes to these estimates will be accepted for billing purposes as the Work proceeds, provided that these changes have the prior approval of the Project Authority, and provided that the estimated cost does not exceed the aforementioned Limitation of Expenditure.
