AMENDMENT 002

The purpose of Amendment 002 is to respond to an inquiry during the solicitation period.

1. Enquiries - Bid Solicitation

To ensure consistency and quality of information provided to bidders, significant enquiries received and the replies to such enquiries will be provided simultaneously to bidders to which the bid solicitation has been sent, without revealing the sources of the enquiries.

Here is the question which we have received:

Question 1: For the 55-point inspections in Annex D – Inspection report, are oil and filter change included or is this only the labor time to do the 55-point inspection?

Answer 1: Reference Annex A – Requirement, Annex B – Basis of Payment and Annex D – Inspection report.

Annex D - Inspection report is only an example of an inspection report. When the Standing Offer becomes effective, for all points on the inspection report, the Offeror must check: S-Satisfactory, C-Can wait or U-Urgent. If an oil change is required, the Offeror will be required to indicate the price of the oil and filter in its Detailed Bid (Reference Annex A - Requirement, Section 6 - Detailed Bid).

The firm unit prices per vehicle to perform the minimum 55-point vehicle inspection must be entered by the Contractor in the Request for Standing Offer, Annex B - Basis of Payment, Section 1. Inspection Services, Item 1. Vehicle inspections in 55-point minimum as described in Annex "D" - Inspection report.

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.
